Comment

This bill authorizes the City to allow 911-operators, jail personnel and EMTs employed by the City to participate in the Missouri Local Government Retirement System. (City of Lee's Summit)

HB1584 - Requires political subdivisions that require the installation of electric vehicle charging stations at certain businesses to pay the costs associated with the installation, maintenance, and operation of such stations

Comment

This bill simply requires that if the City requires the installation of an electric vehicle charging station, the City must pay for such installation and maintenance.

The bill was amended during Perfection to exclude owners who consent or who receive third-party grants and agree to accept the grant funds to partially offset their cost. (City of Lee's Summit)

HB1656 - Specifies that no political subdivision can require its employees to reside within a jurisdiction and changes the law regarding fire marshal employees

Comment

The bill would prohibit any residency requirement for City employees, other than elected officials.

The Perfected bill also excludes positions appointed by the mayor or Council. (City of Lee's Summit)

HB1667 - Creates new provisions relating to the sale of kratom products

Comment

This is another bill preempting any local regulation, this time of Kratom products. The bill prohibits the City from regulating Kratom products and turns over all responsibility to the Department of Health and Senior Services. (City of Lee's Summit)

HB1686 - Creates provisions relating to the right to refuse the COVID-19 vaccine and medical treatment

Comment

The committee substitute prohibits the City from adopting or enforcing any requirement that a person get a COVID vaccination. It does not have a penalty provision against the City.

The Perfected bill does not make any changes to the prohibition against the City enacting or enforcing any COVID vaccination mandate. (City of Lee's Summit)

HB1713 - Establishes the "Missouri Religious Freedom Protection Act"

Comment

This bill would prohibit the City from taking any action to prohibit or limit religious groups from holding services or meetings unless such service or meeting is for the purpose of planning or committing acts of violence or harm. "Religious group" is not defined in the bill.

The bill was Perfected without amendment. (City of Lee's Summit)

HB2382 - Modifies the definition of "sale at retail" for the purposes of sales taxes on certain purchases of utilities

Comment

This bill exempts hotels and motels from sales tax on utilities "included in the charge for such accommodations" (page 6). It directs a refund of any such taxes paid prior to the effective date of the bill without specifying how long prior.

From testimony on the bill, this sales tax has been collected for "about a year". (City of Lee's Summit)

SB672 - Modifies provisions relating to workforce development

During Perfection of the bill it was amended to include the Targeted Industrial Manufacturing Enhancement Zones Act in which the City is interested. (City of Lee's Summit)

SB724 - Modifies provisions relating to financial statements of political subdivisions

Comment

This bill allows taxing authorities which have failed to provide annual financial reports to the State Treasurer or Department of Revenue to substantially reduce their outstanding fines by filing the required reports, but it also authorizes the Attorney General to submit to the voters a ballot issue to dissolve the taxing authority for its continuing violation.

The Perfected bill does not change the waiver of fines for late filings by political subdivisions, but it eliminates the provision for the AG to dissolve the taxing entity. It also adds provisions relating to financial statements of counties and school districts. (City of Lee's Summit)

HB1619 - Prohibits the use of a drone or unmanned aircraft to photograph, film, videotape, create an image, or livestream another person or personal property of another person, with exceptions

Comment

This bill would prohibit any drone filming or "image" of private property by the City without either the consent of the owner or the issuance of a search warrant.

The committee substitute adds an extensive list of exceptions, including some applicable to the City (see page 2), but we are not certain those exceptions cover the potential non-intrusive uses the City may have for using drone images. (City of Lee's Summit)

HB2593 - Prohibits political subdivisions from regulating home-based businesses

Comment

This bill prohibits the City from requiring licensing of or imposing zoning or other restrictions on "no-impact" home based businesses, with "no-impact" including such items as no more employees and customers than the occupancy limit on residential housing, no on-street parking or traffic creating a hazardous condition and occurring in the structure or yard of the residence. (City of Lee's Summit)

SB649 - Modifies provisions relating to taxation

Comment

This bill would require the assessed-value percentage rate on personal property (currently 33 and 1/3%) to be adjusted annually until 2073 in order to maintain the same level of revenue growth from personal property taxes as from real property taxes (which are subject to the Hancock II downward adjustments).

The Perfected bill has become an omnibus tax bill. The adjustment to the assessed value of personal property has been limited to six counties, but one of them is Cass. The bill also (1) caps local combined sales taxes at 3%, (2) provides a real property tax reduction on the homestead of seniors if approved by the City or if petitioned by 5% of the voters and approved by the voters, and (3) exempts certain products from sales tax, including (a) farm equipment, (b) solar energy systems, (c) diapers and (d) certain medical supplies for cancer patients. SJR33 - Modifies provisions relating to taxation

Comment

This Resolution, if approved by the voters, would modify the current prohibition on imposing sales or use taxes on products not previously taxed. It would allow sales and use taxes on subscriptions, digital product licenses and online purchases of tangible personal property. (City of Lee's Summit)

Comment

The primary effect of this bill (at page 7) is to require the ballot to disclose to voters that voting to make a temporary tax levy permanent will result in a permanent increase in the City's tax-rate ceiling. (City of Lee's Summit)

HB1607 - Preempts any laws or orders that would hinder the operations of a firearm business

Comment

This bill would preempt any local regulation of a "firearm business" and prohibit any local regulation of the manufacture, distribution, sale, or training in firearm use, including shooting ranges. (City of Lee's Summit)

HB1611 - Requires candidates for office in political subdivisions to declare a political party affiliation and for that affiliation to be printed on the ballot

Comment

The bill does not specifically abolish non-partisan elections for local offices, but does require each candidate to declare party affiliation, or none, and for the ballot to reflect that declaration. (City of Lee's Summit)

HB1613 - Establishes provisions relating to asset forfeiture

Comment

The bill would prohibit any proceeds of a forfeiture, whether by local police or through federal action, from benefiting the local police; all forfeitures or federal monies resulting from a forfeiture would go into the local school funds. (City of Lee's Summit)

HB1614 - Prohibits the state and any political subdivision from regulating certain uses of private property

Comment

The bill would prohibit the City from regulating vehicles parked on private property if parked on an appropriate surface. Subsection 2. of the bill would also prohibit any regulation of the use of "non-corporate-owned" property unless such use constituted a present danger to the health or safety of "neighbors or passersby". (City of Lee's Summit)

HB1661 - Adds provisions relating to the International Swimming Pool and Spa Code

Comment

The bill mandates the use of the ICC International Swimming Pool and Spa Code as applicable in May 2021 by the City if you are regulating pools in some way, but allows the City to adopt variations to the Code. (City of Lee's Summit)

HB1670 - Creates provisions relating to the COVID-19 vaccines

Comment

The bill prohibits the City from doing any "business" with anyone who requires any of its employees or anyone else to be vaccinated for the COVID virus. The bill does not define or clarify what constitutes "business" with an entity, neither does it specify how the City is to determine whether such entity imposes any COVID-related requirement. (City of Lee's Summit)

HB1685 - Establishes the Targeted Industrial Manufacturing Enhancement Zones Act

Comment

This is authorizes two or more adjoining or overlapping political subdivisions to create Targeted Industrial Manufacturing Enhancement Zones to attract new industry by providing tax breaks for the projects. (City of Lee's Summit)

HB1702 - Modifies court procedures for certain offenses classified or charged as infractions

Comment

The bill prohibits any enforcement action by the municipal court for failure to appear or to pay the fine for a first infraction. Enforcement is limited to notifying the Department of Revenue to enforce the fine when the person seeks to renew his or her license. (City of Lee's Summit)

HB1703 - Establishes the "Peace Officer Basic Training Tuition Reimbursement Program"

Comment

This bill provides a mechanism for trainees to recoup fees for POST training, but the bill also prohibits the City from offering any training in which the trainers and the curriculum have not been approved by POST (page 1, Section 590.060.4). (City of Lee's Summit)

HB1709 - Creates provisions related to certain experimental or investigational medical treatments

Comment

The committee substitute makes it a violation of the Missouri Human Rights Act for the City or any governmental entity or elected or appointed individual to require any person to get a vaccine which has not received full authorization from the FDA. (City of Lee's Summit)

HB2007 - Modifies provisions relating to traffic violations

Sponsor

Comment

This bill would authorize the court, upon notice to the offender, to submit notice to the Department of Revenue if an offender twice failed to appear or failed "without good cause" to pay the fine and costs. The Department would suspend the driver's license of the offender, but would grant limited driving privileges until the court confirmed compliance by the offender. (City of Lee's Summit)

HB2154 - Changes the law regarding cities' ability to regulate fire hydrants

Comment

This bill would require the City to pay for the installation of any fire hydrants within the City and prohibits the City from requiring such installation unless the City pays for it. (City of Lee's Summit)

HB2209 - Changes the law regarding fees by prohibiting fees for parking on public streets or roads

Comment

This bill (last section) would prohibit the City from installing or using parking meters on any public street within the City. Fees for off-street parking would be permitted. (City of Lee's Summit)

HB2214 - Authorizes cities and fire protection districts to impose a public safety sales tax

Comment

This bill would authorize the City (or any city) to adopt a public safety sales tax and/or a fire protection sales tax, but would requires a 4/7ths voter approval.(a little over a 57% majority). (City of Lee's Summit)

HB2220 - Modifies provisions relating to political subdivisions and financial reports

Sponsor

Comment

This is another carrot-and-stick bill providing a reduction in fines for prior failures to provide annual fiscal reports to the State Auditor, but authorizing the Attorney General to submit dissolution of the taxing entity failing to comply. The problem is that the ballot language provides for the dissolution of the City. (City of Lee's Summit)

HB2248 - Changes the law regarding private probation supervision services by prohibiting drug and alcohol screen tests unrelated to the offense and requiring the use of earned compliance credits

Comment

This bill would limit the duration of the term of probation the City could impose from twenty-four to only eighteen months. (City of Lee's Summit)

HB2293 - Exempts certain motor vehicles from sales tax

Comment

This bill would exempt cars and certain vehicles over ten years of age and selling for less than \$25,000 from any State or local sales tax on the sale of the vehicle. (City of Lee's Summit)

HB2359 - Modifies who is required to report and what information is reported to the Missouri Accountability Portal

Sponsor

Rep. Chuck Basye (R)

Comment

The bill expands reporting requirements for cities participating in the program--or forced to by a Petition signed by 5% of the voters. The additional reporting would include compensation or benefits bestowed on City "employees" which is broadly and vaguely defined by the bill to include elected officials and employees of elected officials. (City of Lee's Summit)

HB2439 - Modifies provisions relating to peace officers

Sponsor

Comment

This bill modifies the circumstances for the Director of Public Safety to commence disciplinary proceedings against a police officer. (City of Lee's Summit)

HB2443 - Modifies provisions relating to condemnation proceedings

Sponsor

Rep. David Griffith (R)

Comment

This bill would allow the City to avoid the enhancement of a condemnation award for homestead-taking or heritage value by proving by a preponderance of the evidence that the property was (1) abandoned, (2) determined to be a nuisance and vacated, (3) demolished or repaired after a hearing, or (4) contributing to the designation of a blighted area. (City of Lee's Summit)

HB2454 - Provides that political subdivisions shall not enforce any ordinances struck down by a court and that the chief executive of the political subdivision may be fined for any such enforcement

Comment

This bill requires the mayor to stop all City departments from enforcing an ordinance the court has enjoined or invalidated, to notify the public and to be liable for a civil fine of \$1,000 a day if the mayor knows enforcement is continuing. (City of Lee's Summit)

HB2631 - Creates provisions relating to the unauthorized closure of businesses based on public health concerns

Sponsor

Rep. Jim Kalberloh (R)

Comment

This bill would require any elected official shutting down a private business for a reason not authorized under existing state law or "guidelines" forfeit his or her pay for as long as the business is shut down. While the bill is focused on closures to prevent the spread of COVID, it also includes closures for "any other public health concern". (City of Lee's Summit)

HB2673 - Prohibits political subdivisions from enacting ordinances more restrictive than the federal Clean Air Act

Sponsor

Rep. Hardy Billington (R)

Comment

This bill prohibits the City from enacting or enforcing any ordinance or rule relating to the use of refrigerants which are more restrictive than the federal law. This is the same as HB 2078. (City of Lee's Summit)

HB2705 - Prohibits the use of automated traffic enforcement systems

Comment

The bill prohibits the City from using or enforcing any automated traffic enforcement devices after August 28, 2022, apparently including any "license plate reader" devices. (City of Lee's Summit)

HB2712 - Modifies provisions regarding the Missouri Sunshine Law

Sponsor

Rep. Rodger Reedy (R)

Comment

This is another bill exempting (1) security--including cyber-security measures, (2) citizen e-mail addresses and (3) public utility customer individual records from the Sunshine Law. The bill also includes a deadline for deposit of copying costs before the request is deemed withdrawn. (City of Lee's Summit)

HB2729 - Requires political subdivisions to revise property tax levies as a result of receiving American Rescue Plan funds

Sponsor

Rep. Bishop Davidson (R)

Position

Oppose (City of Lee's Summit)

Comment

The bill would require the City to adjust its property tax rate for 2022 and 2023 to reflect the revenue received from the federal government for COVID Relief. This is substantially the same language as SB 911. (City of Lee's Summit)

HB2753 - Changes the law regarding businesses closed because of a shutdown order

Sponsor

Rep. Dean Plocher (R)

Comment

This bill would require the City to waive or refund prorated business license fees and property taxes for any period the City would close a business in response to the Governor declaring a state of emergency. (City of Lee's Summit)

HB2765 - Creates provisions relating to pole replacements for certain broadband facilities

Sponsor

Rep. Louis Riggs (R)

Comment

The bill creates a fund to reimburse for the cost of utility pole replacement to accommodate broadband expansion, particularly in under-served or unserved areas. (City of Lee's Summit)

HB2786 - Changes the law regarding tobacco products by raising the required age to purchase and possession from eighteen to twenty-one

Sponsor

Rep. Tony Lovasco (R)

Comment

This bill restricts the City from regulating the sale of tobacco, vaping products, or "alternative nicotine products", but allows the City to tax the sale of those products "under other law" (pages 2-3). However, the bill does not specifically repeal Section 149.192 which prohibits any new or increased local taxation of "cigarettes and tobacco products" above levels existing in 1993. (City of Lee's Summit)

HB2809 - Establishes the Preserving Freedom from Unwarranted Surveillance Act

Sponsor

Comment

This bill prohibits law enforcement from using a drone to gather evidence except with a warrant or "any entity" from using a drone to inspect any person, property, or activity. It is similar to HB 1619. (City of Lee's Summit)

HB2831 - Modifies provisions relating to the liability of employers

Sponsor

Rep. Cyndi Buchheit-Courtway (R)

Comment

This bill (pages 6-7) increases the caps on claims excluded from sovereign immunity from two to four million per occurrence and from three to five hundred thousand per person and allows awards of punitive damages upon "clear and convincing evidence" that the City violated "a safety standard issued by the employer" or by OSHA, or a court order. (City of Lee's Summit)

HB2857 - Establishes authority for cities to issue municipal search warrants for ordinance violations

Comment

This bill would authorize municipal judges to authorize search warrants for enforcement of municipal ordinances. (City of Lee's Summit)

HB2873 - Modifies provisions relating to the sunshine law

Sponsor

Rep. David Gregory (R)

Comment

This bill appears to authorize the Secretary of State to act as a "distributor" of Sunshine Law document requests, it requires all custodians of records to provide an e-mail address to the Secretary. It also requires all members of a public governmental body to have an e-mail address "for conducting the business of the public governmental body." (City of Lee's Summit)

HB3004 - To appropriate money for the expenses, grants, refunds, and distributions of the Department of Revenue, the Department of Transportation, and the several divisions and programs thereof

Comment

This is the Appropriations bill for Transportation, including funding for Amtrak service in Missouri at Section 4.530 (currently at page 20). The Governor has recommended and the bill currently provides \$10,850,000 to cover twice a day service. (City of Lee's Summit)

SB686 - Establishes the Missouri Video Lottery Control Act

Sponsor

Position

Oppose (City of Lee's Summit)

Comment

This bill legalizes video lottery games throughout the State. The bill (Section 313.435 at page 20) gives the City 120 days after the effective date of the bill in which to prohibit such video lottery games within the City limits; thereafter, you would have no ability to prohibit such games. (City of Lee's Summit)

SB715 - Authorizes a property tax credit for certain senior citizens

Sponsor

Sen. Steven Roberts (D)

Comment

This bill would authorize the City to adopt an ordinance granting a property tax credit to homeowners over 65 with an income under \$65,000 (or \$130,000 for joint filers) such that their property taxes would not increase over the amount they paid prior to turning 65. (City of Lee's Summit)

SB735 - Modifies provisions relating to certain special taxing districts

Amend (City of Lee's Summit)

Comment

This bill would require the dissolution of any Community Improvement District, Neighborhood Improvement District, or Transportation Development District to dissolve upon completion of the project and payment of any debt; it also requires a TDD to dissolve if the board determines the project can't be completed. In addition, both CIDs and TDDs authorized to impose sales taxes must exempt the sale of food and cannot impose a sales tax which would increase the total sales taxes within the district above 3.25%, excluding State, county and City sales taxes. (City of Lee's Summit)

SB736 - Authorizes a property tax credit as a result of certain restrictive orders

Sponsor

Sen. Andrew Koenig (R)

Position

Oppose (City of Lee's Summit)

Comment

This bill would require the City to give a credit on the owner's property taxes for any period in excess of 15 days that the City imposes a "restrictive order" on the taxpayer's use of real property. The definition does NOT exclude zoning, building, or fire safety codes, it only exempts restrictions "due to a violation of a public health or safety code." Subsection 2 does seem to limit the

credits to "restrictive orders pursuant to Chapter 192", but Subsection 5 again refers to any restrictive order. (City of Lee's Summit)

The Perfected version of this bill authorizes the City to adopt--with voter approval--any special-purpose sales tax provided the total sales taxes imposed by the City do not exceed 4.5%, with any special taxing district within the City having a cap on it's sales taxes at an additional 3%. The bill also eliminates any sales taxes on utilities provided to hotels or other transient accommodation facilities. We do not see an exemption from the sales tax cap for the hotel/motel sales taxes. (City of Lee's Summit)

(City of Lee's Summit)

balance owed on their mortgage. The Resolution provides payment options which would still require 10% of the taxes at the time of closing. If approved by the legislature, this would be submitted to the voters. (City of Lee's Summit)
