

## **BILL NO. 23-070**

AN ORDINANCE APPROVING THE EMERGENCY OPERATIONS PLAN FOR THE CITY OF LEE'S SUMMIT AND AMENDING SECTION 10-7. EMERGENCY OPERATIONS PLAN. OF THE CODE OF ORDINANCES TO REFLECT THE ADOPTION OF THE NEW PLAN.

WHEREAS, many types of man-made or natural hazards can pose safety risks to our community and the protection of people and property within our jurisdiction is an essential function of local government; and,

WHEREAS, Emergency Operations Plan ("EOP") provides a consistent, uniform framework for emergency response and emergency management in the City during disasters; and,

WHEREAS, the updated EOP aligns the City's Emergency Management efforts with nation and state standards and establishes a framework similar to our Emergency Management partners in the metro area; and,

WHEREAS, Missouri Statutes require the City of Lee's Summit to prepare an EOP for the area within the City's jurisdiction; and,

WHEREAS, on June 3, 2004 the City Council adopted enacted Ordinance 5761 adopting the existing EOP; and,

WHEREAS, the City deems it necessary, advisable, and in the best interest of the persons and property within the City to revise and update the EOP; and,

WHEREAS, this updated and revised EOP is consistent with the National Response Framework (NRF); National Incident Management System (NIMS); Comprehensive Preparedness Guide 101; Missouri State Emergency Operations Plan.

NOW, THEREFORE, be it ordained by the City Council of the City of Lee's Summit, Missouri, as follows:

SECTION 1. That the Basic Emergency Operations Plan dated March, 2023 a true and accurate copy being attached hereto as Exhibit A along with any other appendices or addendums deemed necessary in the opinion of the Emergency Management Director and the City Manager, be and the same are hereby approved as the emergency operations plan for the City.

SECTION 2. That Section 10-07 be amended to read as follows:

"Sec. 10-7. - Emergency operations plan.

The emergency operations plan recommended by the Emergency Management Director dated March, 2023, as approved by Ordinance no. \_\_\_\_\_ a true and accurate copy being on file with the City Clerk is hereby adopted as the emergency operations plan for the City."

SECTION 3. That this Ordinance shall be in full force and effect from and after its passage, adoption, and approval by the Mayor.
