I believe we have an energized Council and don't expect that we will have an issue with committee attendance, and am not naming alternates at this time. If it becomes an issue w/meetings being cancelled for quorum, we can revisit.

I would propose that we amend Ordinance 7452, and incorporate the remaining roles of the Environment & Natural Resources Committee, into the responsibility of the Public Works Committee.
