Councilmember Forte said she was excited to be the liaison to the Arts Council and advised Rachel will be leaving soon and Monica Meeks will become the interim director.

Councilmember DeMoro stated the Public Works Committee met yesterday and they will be sending a funding request to the Finance and Budget Committee for funding the stormwater study.

11. Council Comments:

Mr. Steve Arbo, City Manager, introduced Ms. Bette Wordelman, Finance Director, to provide information on the Sales and Use Tax numbers. Ms. Wordelman advised the city had collected 1.3M in sales taxes through 2020 compared to 1.15M in 2019. The Use Tax has already collected \$511,717.90 just December through February.

Councilmember Johnson advised the census will likely be about 6 months late so that will cause a delay in redistricting.

Councilmember Forte conveyed her thanks to the citizens for supporting local businesses during these trying times. Councilmember DeMoro agreed and stated he appreciated all they have done as well.

Councilmember Felker stated he was glad to hear the positive news on taxes.

12. Staff Roundtable

Mr. Steve Arbo, City Manager, noted the License Tax Review Committee Annual Report has been provided to Council as they are required to do so annually. He also expressed his condolences on the passing of Ms. Edna Wider who was a resident of Lee's Summit for many years and she was 102 years young.
