AN ORDINANCE APPROVING THE AWARD OF CONTRACT NO. 2024-005-1, TO PROVIDE A COMPLETE ENTERPRISE RESOURCE PROGRAM AND HUMAN CAPITAL MANAGEMENT SOLUTION TO WORKDAY, INC., AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, through the Procurement and Contract Services Division RFP 2024-005 was issued to select an Enterprise Resource Program (“ERP”) and Human Capital Management (“HCM”) solution to manage the City’s human capital and financial resources; and,

WHEREAS, twelve responses were received in response to RFP 2024-005. A selection committee consisting of staff from ITS, Human Resources, and Finance evaluated each of the proposals. The Committee through multiple rounds of interviews and demonstrations selected Workday as the best solution to meet the City’s needs. AVAAP will facilitate the implementation and training of the solution. Can/Am Technologies will provide the cashiering hardware, setup and integration with the Workday solution; and,

WHEREAS, the City desires to enter into a contractual relationship with Workday, Inc. to provide the ERP and HCM solution through a cloud-based subscription-based model and brings forth the contract for approval.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Contract 2024-005-1 which is attached hereto as Exhibit A and incorporated herein by reference (the “Agreement”), is hereby approved and the City Manager is authorized to execute the Agreement in substantial compliance with the attached version. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the Project for the City. Such changes may include changes to the Agreement, provided that the price paid for the services and the other items which constitute the consideration do not change.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
