AN ORDINANCE APPROVING A TERM EXTENSION UNTIL SEPTEMBER 30, 2024 FOR THE PUBLIC SERVICE AGREEMENT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND DOWNTOWN LEE'S SUMMIT MAIN STREET FOR THE PURPOSES STATED IN THE AGREEMENT; AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit ("City") currently has a Public Service Agreement for various services with Downtown Lee's Summit Main Street ("DLSMS") approved via Ordinance No. 9185; and,

WHEREAS, the City and DLSMS wish to continue the services outlined in the Public Service Agreement, but the parties need additional time and information to draft new agreements; and,

WHEREAS, under the proposed amendments, the term of the agreement will be extended to September 30, 2024 and the City's monthly payments for services will be continued as contemplated by the original agreement for.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The Agreement to Extend the term of the Public Service Agreement between the City and the Downtown Lee's Summit Main Street, attached as Exhibit A and incorporated herein by reference, is hereby approved and shall be extended until September 30, 2024 including extended compensation from the City to DLSMS of \$1500 per month.

SECTION 2. The City Manager is authorized to execute any agreements or other documents necessary to execute this amendment by and on behalf of the City.

SECTION 4. This Ordinance shall be in full force after the date of its passage and approval.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
