## **BILL NO. 18-143**

AN ORDINANCE APPROVING THE AWARD OF BID NO. 18532272-C FOR THE WARD ROAD IMPROVEMENTS (COUNTY LINE ROAD TO GORE ROAD) TO EMERY SAPP & SONS, INC. AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE SAME IN THE AMOUNT OF \$3,979,743.10.

WHEREAS, the Ward Road Improvements (County Line Road to Gore Road), hereinafter the "Project", was part of the 10-year CIP sales tax renewal approved by voters in 2007; and,

WHEREAS, this project will complete storm infrastructure, street lighting, and pedestrian connectivity on Ward Road from County Line Road to Gore Road and enhance the pavement condition along the limits of the route; and,

WHEREAS, six (6) responsive bids for this Project were received by City Staff on or before the August 7, 2018 bid opening date; and,

WHEREAS, Emery Sapp & Sons, Inc. has been identified as the lowest and most responsible bidder for this Project.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT. MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the award of Bid No. 18532272-C for the Ward Road Improvements (County Line Road to Gore Road) to Emery Sapp & Sons, Inc. in the amount of \$3,979,743.10.

SECTION 2. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the City Manager, of an agreement with Emery Sapp & Sons, Inc. for the services contained in Bid No. 18532272-C, generally for the Ward Road Improvements (County Line Road to Gore Road), in an amount of \$3,979,743.10, said agreement is on file with the Lee's Summit Public Works Department and is incorporated by reference as if fully set forth herein.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
