Discussion of issues related to written comments received by the City on City Council agenda items.

Councilmember Felker requested this item be added to the agenda as he had some questions regarding how written public comments are distributed, presented and shared with the public.

The City Clerk explained the current process, mentioning the different ways information has been made available to citizens who wish to speak during the Public Comment section of the agenda.

Brian Head, City Attorney, mentioned some concerns regarding publishing public comments relative to quasi judicial situations that could influencing a Councilmember's decision on an issue. Staff also made the Committee aware that there is current legislation being discussed that might change the public comment process in the future.

Councilmember Edson arrived at the meeting at 12:04 p.m.

After general discussion, Consensus of the Committee was - they are fine with the current process of how public comments are received and then distributed to the Council. They directed staff to add a notation on the Agenda's when a public comment is received on an item and that it is available upon request from the City Clerk's office instead of attaching them to the Approved Action Letter and to also include a note on the Action Letter that there were public comments and how to request them. They were also open to the idea mentioned during the meeting about adding Public Information to the screens in the Council Chambers where the Public can glean information about the Public Comment process as well as community events and other housekeeping items.

Councilmember Felker also asked Staff to briefly update the Council at a future meeting on the changes that have been occurring over the past few months. Specifically regarding:

1. Written instructions for in person attendance that are expounded upon and

- 3. Protocol for meeting decorum and safety relative to not approaching the dais and instead giving any materials to the City Clerk.

6. Roundtable

Items discussed during Roundtable were:

1. Clarifying the City Council Rules and guidelines regarding not using public funds for campaign purposes. Currently in place is Section 12-4 - specifically dealing with not using Staff time and public funds for public forums.

The Committee discussed potential areas of concern and how things can be perceived by the public. In an effort to maintain transparency and ethical practices, the consensus was to change the date in Section 12-4 to the beginning date of candidate filings instead of February 1 each year.

2. Information that is given to candidates prior to the election.

3. On boarding newly elected officials.
