10. Committee Reports

Councilmember DeMoro stated the License Tax Review Committee decided to leave rates the same due to rising costs for residential, commercial and industrial growth.

Councilmember Edson stated CEDC held the annual CDBG hearing and discussed a lot of great projects that will be moving forward. This will be brought to Council soon.

11. Council Comments:

Councilmember Prier asked if the airport has room to expand their runway or is it maxed out?

Mr. Michael Park, Director of Public Works, stated they have no intention to expand the runway. He clarified they are not maxed out but do not have desire to move to another level of service.

Councilmember Lovell noted there has been a lot of discussion on multifamily and rental units that have come online in Lee's Summit over the past 3-5 years. He would like to see an updated on what has been added and where. After brief discussion, staff will make future presentation to update Council on this topic.

Councilmember Lovell also asked about crime statistics for Lee's Summit over the past several years to see how growth has impacted crime. Chief Forbes stated the Police Department participates in national database that provides annual data on crime statistics. However, they have recently changed to this system so there is not a lot of history in that program right now, but this can be provided to Council. He also noted that crime has remained steady with occasional spikes in certain categories that tapers back off.

Councilmember Hodges asked for a breakdown on types of rentals and numbers of each type (government subsidized / non-subsidized, etc.) Mr. Ryan Elam, Assistant City Manager, advised staff can provide an analysis on rental units but not calculate what homes have vouchers but staff could also explain that process at the time of the report.

12. Staff Roundtable

Mr. Mark Dunning, City Manager, advised Lee's Summit would be holding a Career Fair on March 27 - 2nd at Gamber Center from 2pm - 6pm. He also stated this Thursday, March 21, 2024 at 2pm the Fire Department would be holding an event for the hose uncoupling of Fire Station No. 5.
