CRIME FREE LEASE ADDENDUM

CRIME FREE MULTI-HOUSING LEASE ADDENDUM (Missouri Statutes)

In consideration of the execution or renewal of a lease of the dwelling unit identified in the lease, Owner and Resident agree as follows:

Resident, any members of the resident's household or a guest or other persons affiliated with the resident:

- Resident, any member of the Resident's household or a guest or other person affliated with the Resident shall not engage in criminal activity, including drug-related criminal activity, on or off the said premises. "Drug related criminal activity" means the illegal manufacture, sale, distribution, use, or possession with intent to manufacture, sell, distribute, or use an illegal or controlled substance (as defined in Section 102 of the Controlled Substance Act (21 U.S.C.302)).
- Resident, any member of the Resident's household or a guest or other person affliated with the Resident shall not encage in any act intended to facilitate criminal activity, including drug-related criminal activity, on or off the said resumes.
- Resident or any member of the Resident's household will not permit the dwelling unit to be used for, or to
 facilitate criminal activity, regardless or whether the individual engaging in such activity is a member of the
 household, or a rust.
- 4. Resident, any member of the Resident's household or a guest or other person affliated with the Resident shall not engage in the unlawful manufacturing, selling, using, storing, keeping, or giving of an illegal or controlled substance as defined in RSMo. 195.202 through RSMo. 195.218 at any locations, whether on or off the dwelling unit premises or otherwise.
- 5. Resident, any member of the Resident's household or a guest or other person affliated with the Resident shall not engage in any illegal activity, including prostitution as defined in RSMo. 567.020, any criminal street gain activity as defined in RSMo. 562.035, harassment as prohibited in RSMo. 562.035, harassment as prohibited in RSMo. 562.035, harassment as prohibited in RSMo. 567.020, any criminal against persons as prohibited in Chapter 565 of Missouri Statutes, including but not limited to the unlawful discharge or unauthorized possession of firearms as prohibited in RSMo. 579.1.030 on or off the dwelling unit premises, or any breach of the lease agreement that otherwise jeopardizes the health, safety, and welfare of the landlord, his agent, or other tenant, or involving imminent or actual serious property damage, as prohibited in RSMo. 569.100 and RSMo. 569.101.
- 6. VIOLATION OF THE ABOVE PROVISIONS SHALL BE A MATERIAL AND IRREPARABLE VIOLATION OF THE LEASE AND GOOD CAUSE FOR IMMEDIATE TERMINATION OF TENANCY. A single violation of any of the provisions of this added addendum shall be deemed a serious violation, and a material and irreparable non-compliance. It is understood that a single violation shall be good cause for immediate termination of the lease as provided by law, proof of violation shall not require a criminal conviction, but shall be by a preponderance of the evidence.
- In case of conflict between the provisions of this addendum and any other provisions of the lease, the provisions of this addendum shall govern.
- 8. This LEASE ADDENDUM is incorporated into the lease executed or renewed this day between Owner and

1.	No guarantee is to be stated or implied that a property is "free of crime" by virtue of this program			
	alone.			
2.	It is agreed that the use of the Lee's Summit Safe Rental Properties brochures, certificates, and la			
	is granted by the Lee's Summit Police Department, and permission to post brochures, certificates, and			
	logos can be revoked if the property is in non-compliance with the Lee's Summit Safe Rental Properties			
	program.			
3.	If the property landlord, its agents, or management company are in non-compliance with the Lee's			
	Summit Safe Rental Properties program, the use of all brochures, certificates and logos, and any claims to			
	the Lee's Summit Safe Rental Properties program participation must be discontinued.			
4.	Landlord must have knowledge of the Lee's Summit Police Department's reporting activity at the			
	property. Multi-family properties will receive monthly calls for service logs.			
5.	Landlord agrees to utilize the Crime Free Lease Addendum and to serve appropriate eviction or			
	non-compliance notices based upon police generated reports, and to cooperate with police officers,			
	${\tt detectives}, and {\tt the community interaction of ficer in all legitimate investigations and {\tt service} of {\tt warrants} on$			
	the property.			
6.	If participation in the Lee's Summit Safe Rental Properties program is terminated for any reason, the			
	landlord is responsible for turning over program materials (including brochures, certificates, and logos) to			
	the Lee's Summit Police Department within thirty (30) calendar days. The Lee's Summit Police Department			
	reserves the right to confiscate these items if not surrendered upon request, and is not responsible for			
	consequential damages as a result of the seizure.
