AN ORDINANCE APPROVING AMENDMENT NO. 5 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2021, AS ADOPTED BY ORDINANCE NO. 8905 AND ORDINANCE NO. 8906, BY AMENDING THE AUTHORIZED AMOUNT OF FULL TIME EQUIVALENT POSITIONS IN THE PUBLIC WORKS-OPERATIONS DEPARTMENT AND THE CENTRAL BUILDING SERVICES FUND FOR THE CITY OF LEE'S SUMMIT, MISSOURI, AND ESTABLISHING A NEW PAY AND CLASSIFICATION PLAN.

WHEREAS, Ordinance No. 8905 and Ordinance No. 8906, passed by the City Council on June 16, 2020, adopted the authorized expenditures and amount of full time equivalents for the City of Lee's Summit; and,

WHEREAS, to meet the current needs of the Public Works-Operations Department it is necessary to reclassify a Streets Operations Supervisor to a Public Works Operations Supervisor; and,

WHEREAS, it is necessary in the Central Building Services Fund to reclassify a Central Building Services Supervisor to a Facility Maintenance Superintendent in order to be more representative of the type of work being performed; and,

WHEREAS, because this amendment creates and authorizes a new position titled Facility Maintenance Superintendent, the City's Pay and Classification Plan must be amended to include the new position title; and,

WHEREAS, the position reclassifications outlined in this budget amendment are budget neutral.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Fiscal Year 2020-2021 Public Works-Operations Department Full Time Equivalents for certain positions, as adopted by Ordinance No. 8905 and Ordinance No. 8906, is hereby amended as outlined in Exhibit A, attached and incorporated herein by reference.

SECTION 2. The Fiscal Year 2020-2021 Central Building Services Fund Full Time Equivalents for certain positions, as adopted by Ordinance No. 8905 and Ordinance No. 8906, is hereby amended as outlined in Exhibit B, attached and incorporated herein by reference.

SECTION 3. The Fiscal Year 2020-2021 Pay and Classification Plan, as adopted by Ordinance No. 8905 and Ordinance No. 8906, is hereby repealed and replaced by the pay and classification plan attached as Exhibit C and incorporated herein by reference.

SECTION 4. All other provisions of Ordinances No. 8905 and No. 8906 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8937), Amendment No. 2 (Ordinance No. 8941), Amendment No. 3 (Ordinance No. 9007), and Amendment No. 4 (Ordinance No. ____).

SECTION 5. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.
