AN ORDINANCE APPROVING AN AGREEMENT WITH CITYVIEW, A DIVISION OF HARRIS COMPUTER CORPORATION, FOR A THREE-YEAR TERM FOR THE PROVISION OF SOFTWARE MAINTENANCE AND SUPPORT SERVICES, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME ON BEHALF OF THE CITY.

WHEREAS, in August 2008, the City Council approved the award of RFP No. 2007-188 to CityView, a division N. Harris Computer Corporation (“CityView”), through its predecessor Municipal Software, Inc., for the purchase, implementation, and maintenance of permitting and inspections software; and,

WHEREAS, the City’s current agreement for software support for the CityView software system expires on October 31, 2021, and in order to effectively operate the software system, the City must have software support services; and,

WHEREAS, CityView is the sole provider of its GIS software through an enterprise agreement, and is the only company that performs maintenance under such agreements; and,

WHEREAS, City desires to continue receiving software maintenance and support for the CityView software system by entering into an amended and restated software license and support agreement negotiated between City and CityView.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE’S SUMMIT, MISSOURI, as follows:

SECTION 1. The agreement between the City and CityView, a division of N. Harris Computer Corporation, attached as Exhibit A and incorporated by reference, for the provision of three (3) years of software maintenance and support services in an aggregate amount of \$256,366.12 over the life of the agreement, is approved, and the City Manager is authorized to execute the same in substantially the same form as the attached on behalf of the City.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
