

## **BILL NO. 22-66**

AN ORDINANCE AUTHORIZING AN INTERGOVERNMENTAL USER AGENCY AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND THE SOUTHERN JACKSON COUNTY FIRE PROTECTION DISTRICT FOR ACCESS TO THE METROPOITAN AREA REGIONAL RADIO SYSTEM THROUGH THE CITY'S PRIME SITE LINK, AND AUTHORIZING THE MAYOR TO EXECUTE THE SAME.

WHEREAS, the Southern Jackson County Fire Protection District (the "District"), is a Missouri Fire Protection District organized under the provisions of Chapter 321, RSMo.; and,

WHEREAS, the City of Lee's Summit (the "City") radio system infrastructure is a considered a "prime site" link to the Metropolitan Area Regional Radio System ("MARRS"); and,

WHEREAS, the District desires to join the MARRS through the use of the City's prime site link, and the City is willing to allow the District to use its radio system infrastructure; and,

WHEREAS, the City and the District desire to enter into an intergovernmental agreement to allow the District to use the City's prime site link to further local government communications interoperability and improve regional public health, safety, and welfare; and,

WHEREAS, Section 70.220.3, RSMo. requires a contract between a municipality and another political subdivision to be approved by the governing body of said municipality.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The intergovernmental user agency agreement between the City and the Southern Jackson County Fire Protection District authorizing access to the Metropolitan Area Regional Radio System through the City's Prime Site, attached as Exhibit A and incorporated herein by reference, is approved, and the Mayor is authorized to execute the same in substantially the same form as the attached on behalf of the City of Lee's Summit, Missouri.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its adoption, passage and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
