

## **BILL NO. 20-166**

AN ORDINANCE APPROVING A FORM PUBLIC SERVICE AGREEMENT FOR THE DISTRIBUTION OF CORONAVIRUS RELIEF FUNDS TO VARIOUS NONPROFIT ENTITIES AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME ON BEHALF OF THE CITY WITH AWARDED APPLICANTS.

WHEREAS, the President of the United States, the Governor of the State of Missouri, and the Mayor of the City of Lee's Summit (the "City"), have each declared a state of emergency in response to the 2019 novel coronavirus ("COVID-19"); and,

WHEREAS, on March 27, 2020, the United States enacted the Coronavirus Aid, Relief, and Economic Security Act ("CARES Act") which established the Coronavirus Relief Fund (the "Fund") and appropriated \$150 billion to the Fund; and,

WHEREAS, Jackson County, Missouri (the "County") received \$122.7 million from the Fund, and the County, through Ordinance 5372, has appropriated approximately \$36.9 million of its CARES Act funding to the cities within its borders; and,

WHEREAS, the County appropriated to the City an amount not to exceed \$5,921,527.00, and the City may receive its entire appropriation upfront upon the County's approval of the City's budget for spending the Funds; and,

WHEREAS, the City has allocated \$335,000.00 of the Funds it received for economic assistance to be distributed to various non-profit entities; and,

WHEREAS, the City Council desires to facilitate the prompt distribution of Funds to the awarded entities by approving a form public service agreement and authorizing the City Manager to execute such agreement with the awarded entities.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The form public service agreement, attached as Exhibit A and incorporated herein by reference, is hereby approved, and the City Manager is authorized to execute the same in substantially the same form as the attached by and on behalf of the City with entities allocated Coronavirus Relief Funds from the City pursuant to Ordinance No. \_\_\_\_\_.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
