AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 815 FOR THE CRACK SEAL FY24 PROGRAM TO PAVEMENT MANAGEMENT LLC. IN THE AMOUNT OF \$327,000.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, the annual Crack Seal Program extends the life expectancy of pavement surfaces by reducing the frequency and severity of the formation of potholes; and,

WHEREAS, the Crack Seal FY24 Program will seal cracks along approximately 57 lane miles of road (hereinafter "Project No. 815"); and,

WHEREAS, Project No. 815 is funded from the Transportation Sales Tax Fund as part of the FY23 Capital Improvement Plan adopted by City Council; and,

WHEREAS, Public Works Engineering issued an advertisement for bids for Project No. 815 on July 11, 2023, in accordance with local policies and state statutes; and,

WHEREAS, Pavement Management LLC. (hereinafter "Contractor") was determined to be the lowest and most qualified bidder by City staff; and,

WHEREAS, the City and Contractor desire to enter into an agreement for Project No. 815.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 814 to the Contractor in the amount of \$327,000.00

SECTION 2. The agreement between the City of Lee's Summit, Missouri, and the Contractor, attached hereto as "Exhibit A" and incorporated by reference, is hereby approved, and the City Manager, or designee, is hereby authorized to execute the same or substantially similar on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
