8. Committee Reports

Councilmember Edson noted the Legislative and Intergovernmental Relations Committee (LIRC) will meet tomorrow, January 15, 2020 at 5:30 p.m.

Councilmember Forte noted an item was tabled at the Finance & Budget Committee meeting last night. She just wanted to say how nice it is committees can talk about items respectfully. It was done again tonight with Council items and she feels they are getting a lot of good discussion.

9. Council Comments:

Councilmember Binney noted Candidate Filing closes January 21, 2020 at 5:00 p.m.

Mayor Pro Tem Lopez thanked staff for their efforts with the weather the past weekend, he felt the communication was great and he had not heard any complaints. He also said, "Go Chiefs!"

Mayor Pro Tem Lopez also said Mayor Baird had a birthday the past weekend and wished him a happy birthday.

Councilmember Johnson asked if Public Service Agreements (PSAs) were supposed to be going to CEDC, and what are the duties of standing committees as the Community and Economic Development Committee (CEDC) and Public Works Committees (PWC) do not cover financial decisions. Mr. Brian Head, City Attorney, stated each committee is granted different authorities for different subject matter. PWC does make recommendations on Public Works matters. Contracts don't go to multiple committees. The Finance and Budget Committee (F&BC), makes recommendations on City budget and financial matters, but not all contracts. Mr. Head stated this may need to be clarified in Rules.

Mayor Baird stated he felt this was another good meeting. He asked for Council feedback on how he should "push" people along when presentations are getting long and information is being repeated.

10. Staff Roundtable

Mr. Steve Arbo, City Manager, advised that staff had provided City Council with a very in-depth Transit Comp Study in January 2019. This study had many great recommendations, but Council, as a body, asked staff to determine the best use of resources. Staff provided Council with their recommendations and Council approved contracts with OATS for \$240k and \$111k for Ride KC and the City receives a 50% match for transit dollars. Staff also present Council with a fixed route from 3 Trails but the cost would be \$131k for that route; and, \$81k to Independence and back on a fixed route. The Council stated at that time there were better uses for this money.

Mr. Arbo also noted next Tuesday, January 21, 2020, City Council will be meeting at the Missouri Innovation Campus to have a joint meeting with the LSR7 School Board. They are both very positive forward thinking organizations and feels this will be a great meeting. The reception will be from 5:15 p.m. - 6:00 p.m. The meeting from 6:00 pm - 7:30 p.m. Council will have a very brief meeting following the joint session to adopt ballot language for municipal officers election. The meeting will be taped for delayed broadcast.

Councilmember Forte stated her husband informed a coworker about the use of OATS and that other citizens could use this service to get to different locations for a very nominal charge. She feels some education on this throughout the city may be helpful.

Mayor Baird noted he turned 50 years old on January 11 and the Chiefs won the Superbowl on his birthday on January 11, 1970.
