AN ORDINANCE AWARDING THE BID FOR PROJECT NO. 546 FOR THE HANGAR 1 PARKING LOT EXPANSION TO MEGAKC CORPORATION IN THE AMOUNT OF \$145,480.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT FOR THE SAME.

WHEREAS, existing automotive parking areas at the Lee's Summit Municipal Airport are inadequate to meet the daily demand for customers and businesses that use Hangar 1; and,

WHEREAS, Public Works Engineering designed an expansion of the parking capacity at Hangar 1 by twenty-three (23) parking spaces (hereinafter "Project No. 546"); and,

WHEREAS, funding for Project No. 546 is authorized from the Transportation Sales Tax; and,

WHEREAS, Public Works Engineering issued a bid for the construction of Project No. 546 on August 3, 2020, in accordance with local policies and state statutes; and,

WHEREAS, MegaKC Corporation (hereinafter "Contractor") was determined to be the lowest and best bidder by City staff; and,

WHEREAS, the City desires to enter into an agreement with the Contractor to construct Project No. 546.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri, hereby awards the bid for Project No. 546 to the Contractor in the amount of \$145,480.00.

SECTION 2. That the agreement attached hereto as "Exhibit A" by and between the City of Lee's Summit, Missouri, and the Contractor is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
