AN ORDINANCE APPROVING THE AWARD OF BID NO. 7207-C FOR A ONE YEAR CONTRACT WITH THREE (3) POTENTIAL RENEWAL PERIODS OF ONE YEAR EACH FOR STREET LIGHT AND TRAFFIC SIGNAL SERVICES TO CUSTOM LIGHTING SERVICES, LLC, DBA BLACK AND MCDONALD BASED ON UNIT PRICES REFLECTED IN THE ATTACHED BID TABULATION AND AUTHORIZING THE CITY MANAGER TO ENTER INTO AN AGREEMENT FOR THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT.

WHEREAS, the Public Works Department requires an on-call contract to support its responsibility for the maintenance and repair of the City's street light and traffic signal infrastructure; and,

WHEREAS, the previous on-call contract was authorized in 2012 and has recently expired. The services provided in that contract were of value to the City, and the proposed on-call contract would expand those same previous services by including an emergency response call-out for damage to critical infrastructure; and,

WHEREAS, the on-call contract may also be used for minor improvements; and,

WHEREAS, the bid from Custom Lighting Services, LLC offered the best responsive bid that met all specifications.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the award of bid no. 7207-C, generally for a one year contract with three potential renewal periods of one year each for street light and traffic signal services, to Custom Lighting Services, LLC, dba Black and McDonald based on unit prices reflected in attached bid tabulation.

SECTION 2. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the City Manager, of an agreement with Custom Lighting Services, LLC, dba Black and McDonald for the services contained in bid no. 7207-C, generally for a one year contract with three potential renewal periods of one year each for street light and traffic signal services, to Custom Lighting Services, LLC, dba Black and McDonald based on unit prices reflected in attached bid tabulation, said agreement is on file with the Lee's Summit Public Works Department and is incorporated by reference as if fully set forth herein.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
