AN ORDINANCE APPROVING AMENDMENT NO. 8 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020, AS ADOPTED BY ORDINANCE NO. 8643 AND ORDINANCE NO. 8652, BY AMENDING THE AUTHORIZED EXPENDITURES AND REVISING THE AUTHORIZED AMOUNT OF FULL TIME EQUIVALENTS IN THE AIRPORT FUND FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Ordinance No. 8643 and Ordinance No. 8652, passed by the City Council on June 11, 2019, adopted the authorized expenditures and amount of full time equivalents for the City of Lee's Summit; and,

WHEREAS, the Airport Fund submitted expansion requests to increase the number of Airport Attendants; and,

WHEREAS, the City Council approved the Airport Fund expansion requests as part of FY19 Budget Amendment No. 1 (Ordinance No. 8457) pending additional revenue being made available to fund the expansion requests; and,

WHEREAS, to maintain current service levels with current operations the Airport needs to use more part-time hours in order to sell additional fuel and meet customer demands; and,

WHEREAS, the Airport Fund has increased revenue sufficient enough to support an increase in additional hours for part-time Airport Attendants.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2020, of the City of Lee's Summit, Missouri, are amended in the following manner:

SECTION 2. The Fiscal Year 2019-2020 Airport Fund Full Time Equivalents for certain positions, as adopted by Ordinance No. 8643, is hereby amended as outlined in Exhibit A and incorporated herein by reference.

SECTION 3. All other provisions of Ordinances No. 8643 and No. 8652 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8653), Amendment No. 2(Ordinance No. 8660), Amendment No. 3 (Ordinance No. 8707), Amendment No. 4 (Ordinance No. 8721), Amendment No. 5 (Ordinance No. 8808), Amendment No. 6 (Ordinance No. _____), and Amendment No. 7 (Ordinance No. _____).

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
