B. 2023-5839 Continued Discussion: Lobbyist RFP and Contract

At the previous meeting, the Committee asked Staff to do some further research regarding the candidate's application and requested to see a sample report.

Brian provided a sample report from the candidate prior to the meeting. Consensus of the Committee was they were happy with the level of detail provided.

Mayor Baird arrived at the meeting at 11:43 a.m.

The Committee also asked for clarification of "additional expenses" mentioned in the candidate's application. Brian informed the Committee that the candidate was used to being required to travel to conferences on behalf of some larger clients he works with. In the event that the City of Lee's Summit required him to attend a conference, there would be "additional expenses".

The Committee was also curious as to why the City only received one application and wanted Brian to ask our previous lobbyist for his thoughts.

Mr. Durham had two thoughts about that and explained that most lobbyists do not actively look for available jobs and instead go by word of mouth. The second thought could be that it was not well known that Mr. Durham would no longer be working with the City of Lee's Summit and therefore it was probably assumed that there wasn't a vacancy available.

After brief discussion, a motion was made.

Councilmember Lovell made a motion to authorize the City Attorney to finalize negotiations with the applicant and move this item to the Council with a recommendation of approval. Mayor Baird seconded the motion. The motion passed 4-0.
