### REASON FOR LETTER:

VERY FEW PEOPLE COME DOWN OUR ALLEY EXCEPT OUR RENTER'S AND THE MESSY PEOPLE LIVES ON THE EAST SIDE OF THE ALLEY, OUR GOOD LOYAL RENTER'S HAVE NOTICED THIS, MESS IN THEIR YARDS.
