

## **BILL NO. 17-219**

AN ORDINANCE APPROVING THE AWARD OF RFP NO. 2017-122 FOR A YEARLY AGREEMENT WITH FOUR POSSIBLE ONE-YEAR RENEWALS FOR AVIATION FUEL SERVICES FOR THE AVIATION DIVISION OF PUBLIC WORKS TO AVFUEL CORPORATION FOR AN AMOUNT NOT TO EXCEED \$686,354.00 AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the Aviation Fuel Service Program is a key element for the revenues of the Aviation Division; and,

WHEREAS, the FY2018 Aviation Fuel Service Program will provide for the purchase and resale of 110,000 gallons, 80,000 gallons of 100LL AVGAS, the rental of two mobile re-fuelers, POS processing, participation in Aviation Trade shows and the purchase of specialize aviation quality control equipment; and,

WHEREAS, Aviation fuel services is a specialized service, which is performed by contractors that perform this service; and,

WHEREAS, the City issued RFP No. 2017-122 for the FY2018 Aviation Fuel Services Program; and,

WHEREAS, of the proposals received, AVFUEL Corporation, Inc. has been determined to be the highest ranking firm by the project evaluation committee.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the award of RFP No. 2017-122 for a yearly agreement with four possible one-year renewals for aviation fuel services for the Aviation Division of Public Works to AVFUEL Corporation, Inc. for an amount not to exceed \$686,354.00.

SECTION 2. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the City Manager, of an agreement with AVFUEL Corporation, Inc. for the services contained in RFP No. 2017-122, for an annual agreement with four possible one-year renewals for aviation fuel services for the Aviation Division of Public Works to AVFUEL Corporation, Inc. for an amount not to exceed \$686,354.00 said agreement being attached hereto as "Exhibit A" and incorporated by reference as if fully set forth herein.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
