

## **BILL NO. 20-178**

AN ORDINANCE AUTHORIZING THE APPROVAL OF A CORONAVIRUS AID, RELIEF, AND ECONOMIC SECURITY ACT AGREEMENT IN THE AMOUNT OF \$69,000 THROUGH TITLE XII OF THE DIVISION B OF THE CARES ACT FOR THE LEE'S SUMMIT MUNICIPAL AIRPORT FOR THE PURCHASE OF 107 AIRFIELD LIGHT MATS FOR LIGHTING ON RUNWAY 18/36 AND THE THRESHOLD LIGHTS FOR APPROXIMATELY \$23,000 AND THE REMAINING FUNDS, OF APPROXIMATELY \$46,000 WILL BE APPLIED TOWARDS OFFSETTING ONGOING OPERATING EXPENSES DUE TO THE COVID-19 PANDEMIC AND AUTHORIZING THE MAYOR TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY OF LEE'S SUMMIT.

WHEREAS, the City of Lee's Summit owns and operates the Lee's Summit Municipal Airport (hereinafter "Airport") which includes the maintenance and operations of the airfield, hangars and Fixed Base Operations (FBO) for fuel and hangar storage; and,

WHEREAS, the Airport, through the City Council, periodically accepts federal and state aviation grants for the development and operations of the airport facilities and operations; and,

WHEREAS, the Missouri Department of Transportation (MODOT) State Aviation Section has offered through the Federal Aviation Administration (FAA) has offered a Coronavirus Aid, Relief, and Economic Security Act Agreement in the amount of \$69,000 through Title XII of the Division B of the CARES ACT for the Lee's Summit Municipal Airport for the purchase of 107 airfield light mats for lighting of Runway 18/36 and the threshold lights for approximately \$23,000 and the remaining funds, of approximately \$46,000 will be applied towards offsetting ongoing operations expenses due to the COVID-19 pandemic; and,

WHEREAS, MoDOT Aviation Section through the FAA has offered the City a Coronavirus Aid, Relief, and Economic Security Act Agreement in the amount of \$69,000 for the purchase of airfield light matting for Runway 18/36 and ongoing operations expenses at the Airport per the terms and conditions of the Grant provided; and,

WHEREAS, City and Missouri State Aviation Section wish to enter into a State Block Grant Agreement.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the Coronavirus Aid, Relief, and Economic Security Act Agreement by and between the City of Lee's Summit, Missouri and MoDOT Aviation Section attached hereto as Exhibit "A" and incorporated herein by reference, be and the same is hereby approved. The Mayor is hereby authorized to execute the same by and on behalf of the City of Lee's Summit, Missouri.

SECTION 2. That this ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. That should any section, sentence, or clause of this ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
