A. 2023-6047 Approval of the November 13, 2023 Legislative Intergovernmental Relations Committee Action Letter.

Councilmember Lovell made a motion to approve the November 13, 2023 Legislative and Intergovernmental Relations Committee meeting. Motion was seconded by Mayor Baird. Motion passed 4-0.

B. 2023-6046 Discussion: Lobbyist Report

Brian Head started the conversation by asking the Committee if they had any comments regarding the format of the Lobbyist report. Comments from the Committee were positive, they appreciated the level of detail provided and didn't make any suggested changes.

Brian highlighted a few of the bills as follows:

- 1. HB 1438 Solid Waste/Landfill changes the distance and amount of time for us to conduct a hearing.
- 2. Tax Assessment Issue House joint Resolution 68 which would amend the constitution to require the Jackson County Assessor be elected rather than appointed if approved by the voters of the State.
- 3. SB 919 Any CID that would impose a sales tax would require a 2/3 majority vote of the City Council to authorize formation of the CID instead of a simple majority.
- 4. Possible Election Calendar changes due to holidays

Mayor Baird was concerned with the timeliness of the bills with regard to updates impacting us relative to our sister cities and mentioned letting our lobbyist know that more frequent updates would be desired to ensure accuracy with the information received.

Brian said he would talk with the lobbyist regarding this request.

C. RES. NO. 24-02

A Resolution expressing the opposition of the Council of the City of Lee's Summit, Missouri to the location of a landfill or other facility involved in solid waste hauling near the City's border.

Brian updated the Committee on Resolution 24-02 regarding changing some language to broaden the range of the City's role in landfill/solid waste decisions for the current legislative season.

Specifically:

Whereas, "The City Council is opposed to the location of a landfill or other facility involved in solid waste hauling near the border of the City, and supports legislation to give the City of Lee's Summit and other impacted governmental

entities significant input into the siting of such a landfill or other facility involving solid waste hauling."

After brief discussion, a motion was made.

Mayor Baird made a motion to approve Resolution 24-02 and send it to the City Council for approval. Motion was seconded by Councilmember Prier. Motion passed with vote 4-0.

- 1. Mayor Baird reminded the Committee that the annual MML event is Feb. 20 and 21, 2024.
- 2. Brian Head mentioned an item regarding a paint recycling program at the State Level. He will send out information prior to the next meeting and add the topic to the agenda for discussion. If there is an interest in pursuing this he will let our Lobbyist know.
- 3. Mayor Baird informed the Committee that he was successful in getting a meeting with Congressman Grave's office. Congressman Graves is the Chair of the Infrastructure and Transportation Committee. Staff met with his Legislative Aid to discuss the 470 corridor and requested assistance due to the amount of growth on 470 corridor going up to 70 highway and the congestion issues already in that area.

He said the meeting was well received and that he was told it would probably take state and federal funds. Mark Dunning is corresponding with his office to keep these concerns and the request for assistance "on the table".
