

## **BILL NO. 22-47**

AN ORDINANCE APPROVING THE DUAL AWARD OF BID NO. 2022-024, TO PURCHASE WATER OPERATIONS PARTS AND MATERIALS ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO CORE & MAIN, LP AND BLUE SPRINGS WINWATER, INC., AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2022-024 ("Bid") for water operations parts and materials; and,

WHEREAS, the Bid was advertised through the City's e-procurement system, Public Purchase, which notified 36 potential bidders; and,

WHEREAS, at the close of the Bid two (2) bidders had submitted responsive and responsible bids; and,

WHEREAS, based upon the evaluation of responses and bid criteria, the City recommends awarding of the Bid to Core & Main, LP and Blue Springs Winwater, Inc.; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if a City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's dual award of Bid No. 2022-024 to Core & Main, LP and Blue Springs Winwater, Inc. for the purchase of water operations materials.

SECTION 2. The agreements between the City and Core & Main, LP, attached as Exhibit A and incorporated herein by reference, and between the City and Blue Springs Winwater, attached as Exhibit B and incorporated herein by reference, are approved, and the City Manager is authorized to execute the same in substantially the same form as the attached, on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
