AN ORDINANCE APPROVING A MICROSOFT ENTERPRISE AGREEMENT GOVERNMENT THROUGH RESELLER SHI CORP FOR A VOLUME LICENSING PROGRAM AND THE PURCHASE OF CLOUD SERVICES AND SOFTWARE LICENSES UNDER ONE AGREEMENT FOR MICROSOFT 365, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, through the City's Procurement and Contract Services Division the CO-OP agreement 2023-004/1R was renewed, and pricing proposals for Microsoft 365 Government subscription services to manage the City's core security, identify management capabilities and provide Office 365 productivity solutions were obtained and evaluated; and,

WHEREAS, quotes were received from 2 vendors under State CO-OP agreements for a Microsoft Enterprise Agreement volume pricing; and,

WHEREAS licensing profile reviews and consulting sessions were performed by ITS to identify the plans which best meets the City's requirements and the determination was made that the subscription services which best meet the City's needs are provided by SHI as a reseller to Microsoft for the Enterprise Agreement subscription licensing services together with ConvergeOne (C1) providing the implementation professional services; and,

WHEREAS, the City desires to enter into a Microsoft Enterprise Agreement with SHI as the Microsoft reseller to purchase Microsoft 365 subscription services:

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Microsoft Enterprise Agreement which is attached hereto as Exhibit A and incorporated herein by reference (the "Agreement"), is hereby approved and the City Manager is authorized to execute the Agreement in substantial compliance with the attached version. The City Council hereby delegates authority to City staff to negotiate such changes to the Agreement and its exhibits as are necessary to complete the Agreement and carry out the purposes and intent of the project for the City. Such changes may include changes to the Agreement, provided that the price paid for the services and the other items which constitute the consideration do not exceed the appending authority granted in this ordinance.

SECTION 2. The City Manager is hereby authorized to spend up to \$991,290.00 for the services to be received by the city under the Microsoft Enterprise Agreement approved in Section 1 above.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
