AN ORDINANCE ACKNOWLEDGING AND APPROVING THE RE-ACCREDITATION AGREEMENT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND ACCREDITATION COUNCIL OF THE APWA, A DIVISION OF THE AMERICAN PUBLIC WORKS ASSOCIATION, FOR THE PURPOSE OF ENGAGING IN A RE-ACCREDITATION PROCESS FOR THE CITY OF LEE'S SUMMIT PUBLIC WORKS DEPARTMENT AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME.

WHEREAS, the American Public Works Association (hereinafter "APWA") began an accreditation program in 1996 for the purpose of "enhanc[ing] the effectiveness of agencies and their competencies in the public works field"; and,

WHEREAS, the City of Lee's Summit Public Works department (hereinafter "LSPW") first achieved accreditation from the APWA in 2004; and,

WHEREAS, the APWA requires re-accreditation every four (4) years; and,

WHEREAS, LSPW received re-accreditation through APWA in 2008 and 2012; and

WHEREAS, in order to maintain accreditation through the APWA, LSPW needs to again seek re-accreditation; and,

WHEREAS, APWA has proposed a Re-Accreditation Agreement which sets forth the terms and conditions associated with the re-accreditation process for LSPW for 2016 re-accreditation; and,

WHEREAS, LSPW agrees with the terms and conditions of the Re-Accreditation Agreement and wishes to enter into the same with APWA in order to finalize the 2016 re-accreditation process.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the Re-Accreditation Agreement by and between the City of Lee's Summit, Missouri and the Accreditation Council of the APWA, a Division of the American Public Works Association, attached hereto and incorporated herein as Exhibit A, generally for the purpose of the re-accreditation of the Lee's Summit Public Works department by the APWA, be and hereby is acknowledged and approved, and the City Manager is hereby authorized and directed to execute the same on behalf of the City.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. That should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
