**7. COUNCIL ROUNDTABLE:**

Councilmember Binney asked for an update on legislating trash haulers. Mr. Brian Head, City Attorney, advised the city cannot govern trash haulers as they are private businesses. It is possible to enact minimum standards, but there is no way for the city to enforce regulations. He suggested citizens switch to a different carrier if they are unhappy with their current service.

Councilmember Binney thanked the Public Works Department for their hard work on the Big Truck and Equipment Show that was held in the City Hall Plaza last Saturday, May 14. He felt it was a huge success and enjoyed his time at the show.

Councilmember Binney reminded the public of the upcoming Open House at the Lee's Summit Airport on Saturday, June 19th. This will be another exciting opportunity for citizens.

Councilmember Binney congratulated Mrs. Dena Mezger on her achievement of earning the designation of one of the Top 10 Public Works officials in the United States.

Councilmember Binney thanked Councilmember Forte for the update on projects from the Communications Task Force, but asked that more specific information be provided on the topics within the update.

Councilmember Moreno asked that staff work on performance standards regarding trash haulers. The Council did not agree to directing staff to do

so as this is a private company matter and cannot be enforced by city staff.

Councilmember Edson thanked the Fire Department for their work and dedication to the Fire Ops 101 class. She learned a lot from them and it made her appreciate their hard work even more.
