#### 8. Proposed Ordinances - First Reading:

A. <u>BILL NO.</u> An Ordinance amending the Code of Ordinances Section 2-2. City holidays, to add Juneteenth and Veterans Day as official City Holidays. (F&BC 5/6/24)

This item was removed by Mayor Pro Tem Lopez during the approval of the agenda. It will be placed on a future Council agenda when the full Council will be present.

**B.** BILL NO. 24-085

An Ordinance amending the Code of Ordinances Section 2-339 Determination of Final Average Salary to change the time period used for determining a member employee's final average salary from a sixty (60) consecutive-month period to a thirty-six (36) consecutive-month period with the Missouri Local Government Employees Retirement System. (F&BC 5/6/24)

Councilmember Shields advised the May 20, 2024 Finance and Budget Special Session is being cancelled due to lack of quorum since the new committees have not been appointed yet.

Councilmember DeMoro he would like Council to review which meetings boards commissions are televised recorded and live and broadcast later for purposes of transparency. Many of the boards and commissions have been repositioned and with the new technology and staffing abilities he would like to see more meetings broadcast and recorded for public viewing.

Mr. Mark Dunning, City Manager, noted along with the high school and college graduations happening, Leadership Lee's Summit is also graduating this Saturday and many members of staff will be graduates at this event. He recognized and congratulated each of them.

Mr. Dunning also advised that this would likely be the last Council meeting for Ms. Bette Wordelman, Finance Director. She has spent 7 years with the City and will be retiring at the end of this week. He thanked her for her years of service with the City and congratulated her on her retirement.
