

## **BILL NO. 20-156**

AN ORDINANCE APPROVING AMENDMENT NO. 1 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2021, AS ADOPTED BY ORDINANCE NO. 8905 AND ORDINANCE NO. 8906, BY AMENDING THE AUTHORIZED EXPENDITURES IN THE PUBLIC SAFETY EQUIPMENT REPLACEMENT PROGRAM FUND FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Ordinance No. 8905 and Ordinance No. 8906, passed by the City Council on June 16, 2020, adopted the authorized expenditures and amount of full time equivalents for the City of Lee's Summit; and,

WHEREAS, the Fire Department was notified that a version of five of the LIFEPAK devices in the current inventory are experiencing a series of early failures with an internal component that cannot be replaced; and,

WHEREAS, the manufacturer is offering a special reduced price to replace the five LIFEPAK devices; and,

WHEREAS, funds have been incrementally set aside to pay for the replacement of the LIFEPAK devices and the set aside funds in the Public Safety Equipment Replacement Program (PSERP) fund balance are enough to cover the special reduced price of the five LIFEPAK devices; and,

WHEREAS, funds were transferred from the General Fund to the PSERP Fund as part of the FY20 budget for Fire Station 3; and,

WHEREAS, only a portion of the funds were expended in FY20 and the remainder of the funds need to be expended in FY21; and,

WHEREAS, the budget amendment will amend the authorized expenditures in the PSERP Fund to include the funds for the LIFEPAK devices and Fire Station 3.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The authorized expenditures for the Fiscal Year ending June 30, 2021, of the City of Lee's Summit, Missouri, are amended in the following manner:
