

## **BILL NO. 20-191**

AN ORDINANCE APPROVING THE AWARD OF CONTRACT NO. 2021-001, TO PURCHASE FUEL PRODUCTS AND SERVICES ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO JOHN MOORE OIL COMPANY AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2021-001 for fuel products and services ("Bid"); and,

WHEREAS, Bid No. 2021-001 was advertised through the City's e-procurement system, Public Purchase, and sent to 34 potential bidders; and,

WHEREAS, at the close of the Bid two (2) bidders had submitted responsive and responsible bids; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if a City contract is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri hereby approves the City's award of Contract 2021-001 between the City and John Moore Oil Company, attached as Exhibit A and incorporated herein by reference, to purchase fuel products and services and the City Manager is authorized to execute the same in substantially the same form as the attached by and on behalf of the City.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
