

## **BILL NO. 18-34**

AN ORDINANCE SUBMITTING TO THE ELECTORS OF THE CITY OF LEE'S SUMMIT, MISSOURI, AT A SPECIAL MUNICIPAL ELECTION ON TUESDAY AUGUST 7, 2018, THE QUESTION OF WHETHER THE CITY SHALL IMPOSE A CITY SALES TAX OF ONE-HALF OF ONE PERCENT (1/2 OF 1%); PRESCRIBING A FORM OF BALLOT; AND CONTAINING AN EMERGENCY CLAUSE.

WHEREAS, the City Council has determined that sources of revenue currently available to the City to provide appropriate funding for general municipal government are inadequate and that additional revenue is needed to provide for continued growth and maintenance of current services.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That there be submitted to the qualified electors of the City of Lee's Summit, Missouri, at a Special Municipal Election to be held in said City on the 7<sup>th</sup> day of August, 2018, the following question concerning whether the City of Lee's Summit shall impose an additional Sales Tax in the amount of one-half of one percent (1/2 of 1%) for general municipal purposes, pursuant to the provisions of V.A.M.S. §94.510, et. seq., said question to be as follows:

"Shall the City of Lee's Summit, Missouri impose a city sales tax of one-half of one percent (1/2 of 1%)?"

SECTION 2. That the form of the Notice of Special Election for said special election, a copy of which is attached hereto and made a part hereof, is hereby approved.

SECTION 3. That the City Clerk is hereby authorized and directed to notify the Board of Election Commissioners of Jackson County, Missouri, and the County Clerk of Cass County, Missouri, of the adoption of this Ordinance no later than 4:00 P.M. on May 29, 2018, and to include in said notification all of the terms and provisions required by the Comprehensive Election Act, Chapter 115 of the Revised Statutes of Missouri, as amended.

SECTION 4. That in addition to all sales taxes currently imposed in the City of Lee's Summit, Missouri, a sales tax in the amount of one-half of one percent (1/2 of 1%) is hereby imposed upon the receipts from the sale at retail of all tangible personal property or taxable services at retail within the City as provided by the provisions of sections 144.010 to 144.525 RSMo., upon approval by the required majority of voters of the ballot question hereinabove described in Section 1.

SECTION 5. That this Ordinance calling an election and submitting a proposition to the voters, is an emergency within the meaning of Section 3.13(f)(4) of the Charter of the City of Lee's Summit, Missouri, and, the same shall be in full force and effect immediately from and after its adoption and approval by the Mayor.
