AN ORDINANCE APPROVING AMENDMENT NO. 3 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2023, AS ADOPTED BY ORDINANCE NO. 9441, ORDINANCE NO. 9442, ORDINANCE NO. 9449, ORDINANCE NO. 9450, AND ORDINANCE NO. 9451, BY AMENDING THE FULL TIME EQUIVALENT POSITIONS FOR THE POLICE DEPARTMENT FOR THE CITY.

WHEREAS, pursuant to Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451, on June 21, 2022, the City Council adopted the authorized Full Time Equivalent (FTEs) for positions in the City of Lee's Summit; and,

WHEREAS, on April 5, 2022 the citizens of the City of Lee's Summit, Missouri approved a half-cent Public Safety Sales Tax; and,

WHEREAS, the Lee's Summit Police Department identified the need to request an expansion of six (6) full time equivalent Police Officer positions; and,

WHEREAS, a future budget amendment to request authorization to spend Public Safety Sales Tax funds will be coming for the anticipated expansion requests with the cost of salary, benefits, equipment, and vehicles; and,

WHEREAS, this action will give the Police Department the ability to start recruiting individuals for the expansion positions; and,

WHEREAS, this action will not amend the total authorized expenditures for the Police Department.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Fiscal Year 2022-23 Police Department Full Time Equivalent for certain positions, as adopted Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451 is hereby amended as set forth in Exhibit A, attached and incorporated herein by reference.

SECTION 2. All other provisions of Ordinance No. 9441, Ordinance No. 9442, Ordinance No. 9449, Ordinance No. 9450, and Ordinance No. 9451 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 9482).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
