## 12. Staff Roundtable

Ms. Christal Weber, Assistant City Manager, stated the Cultural and Wellness Commissions will present to Council on April 23, 2024. There has been a lot of work with Amtrak and Amtrak partners regarding the World Cup preparations. She also noted the Destination Marketing Organization will be presenting to Council in May and will also include information on the World Cup preparations.
