AN ORDINANCE AUTHORIZING THE EXECUTION OF MODIFICATION NO. 2 TO THE AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES WITH BARTLETT & WEST INC., FOR THE LANGSFORD ROAD BRIDGE REHABILITATION (RFQ NO. 44112-D) IN THE AMOUNT OF \$22,215.00 FOR A REVISED CONTRACT AMOUNT OF \$386,530.50 AND CONTAINING AN EMERGENCY CLAUSE.

WHEREAS, the City and Engineer entered into an Agreement for professional engineering services for the Murray Road Culvert Rehabilitation and Bridge Evaluation Services; and,

WHEREAS, the City desires to initiate repairs of the Langsford Road Bridge in order to increase its service life; and,

WHEREAS, this project is approved in the Capital Improvement Plan (CIP), and funded by the CIP Sales Tax; and,

WHEREAS, the adoption of this Ordinance relates to the immediate preservation of the public peace, health and safety; and

WHEREAS, City and Engineer desire to modify Articles I, IV and V of the Base Agreement.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit hereby approves Modification No. 2, RFQ No. 44112-D, to the professional engineering services agreement with Bartlett & West, Inc., generally for purpose of the provision of engineering services to design the Langsford Road Bridge Rehabilitation, a true and accurate copy being attached hereto and incorporated herein by reference as if fully set forth herein, is hereby approved and the City Manager is hereby authorized to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 2. That this ordinance authorizing engineering services to deal with a compromised section of pipe and protect the City's infrastructure from possible collapse is necessary for the immediate preservation of the public peace, health and safety and is an emergency within the meaning of Section 3.13(f)(1) of the Charter of the City of Lee's Summit, Missouri. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
