

BILL NO. 24-002

AN ORDINANCE APPROVING THE 2024 JACKSON COUNTY BOARD OF ELECTION COMMISSIONERS POLL CONTRACTS FOR THE LOVELL COMMUNITY CENTER, HARRIS PARK COMMUNITY CENTER, LONGVIEW COMMUNITY CENTER AND THE GAMBER CENTER, AND AUTHORIZING THE ADMINISTRATOR OF PARKS AND RECREATION TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, the City of Lee's Summit is a constitutional charter City, organized and existing under the laws of the State of Missouri (the "City"); and,

WHEREAS, the Lee's Summit Parks and Recreation Board (the "Board") is empowered with the control of the supervision, improvement, care and custody of parks and recreation activities in the City of Lee's Summit, Missouri; and,

WHEREAS, the Jackson County Board of Election Commissioners ("JCBE") is a political subdivision which exists for the purpose of conducting all public elections for various political subdivisions within its' jurisdiction, which includes the City of Lee's Summit, Missouri; and,

WHEREAS, JCBE regularly uses various facilities owned by the City and the Board to serve as polling places for public elections; and,

WHEREAS, JCBE has requested the use of the Lovell Community Center, Harris Park Community Center, Longview Community Center and the Gamber Center for polling places for the 2024 elections to be held on April 2, August 6, and November 5, as well as the February 4, 2025 election, and has presented to the Board and the City Polling Contracts to formalize agreements for said use; and,

WHEREAS, Section 70.220, RSMo. requires that any contract entered into between a municipality and another political subdivision be approved by the municipality's governing body.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The Polling Contracts between the City of Lee's Summit, Missouri, by and through Lee's Summit Parks and Recreation, and the Jackson County Board of Election Commissioners attached as Exhibits A, B, C and D, and incorporated herein by reference are hereby approved, and the Mayor is authorized to execute the same by and on behalf of the City of Lee's Summit, Missouri.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
