

## **BILL NO. 23-015**

AN ORDINANCE APPROVING MODIFICATION NO. 2 TO AN AGREEMENT FOR PROFESSIONAL ENGINEERING SERVICES FOR THE EAST FORK OF LITTLE BLUE RIVER WATERSHED STORMWATER IMPROVEMENT PROJECT (SOLE SOURCE) BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND ALLGEIER, MARTIN & ASSOCIATES, INC., FOR AN INCREASE OF \$29,000.00 FOR THE AMENDED BASIC AND OPTIONAL SERVICES, WITH AN AMENDED NOT TO EXCEED AMOUNT OF \$653,000.00, AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME.

WHEREAS, pursuant to Ordinance No. 9077, the City and Allgeier, Martin & Associates, Inc. ("Engineer") entered into an Agreement for Professional Engineering Services for the East Fork of Little Blue River Watershed Stormwater Project (Sole Source) dated February 23, 2021 ("Base Agreement"); and,

WHEREAS, pursuant to Ordinance No. 9308, the City and the Engineer modified the Base Agreement to provide Services described in Modification No. 1 to the Base Agreement; and,

WHEREAS, the City desires to further modify the Base Agreement with the Engineer to include additional professional engineering services as contemplated in the Base Agreement ("Modification No. 2").

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council of the City of Lee's Summit, Missouri, hereby approves Modification No. 2 for an increase of \$29,000.00 for the amended Basic and Optional Services with an amended not to exceed the amount of \$653,000.00, substantially similar to said modification agreement attached hereto as "Exhibit 1".

SECTION 2. The City Council of the City of Lee's Summit, Missouri, hereby authorizes the City Manager, or designee, to execute the same on behalf of the City of Lee's Summit, Missouri.

SECTION 3. The City Manager, or designee, is further authorized to take such further action and execute such documents as may be necessary or desirable to carry out and comply with the intent of this Ordinance.

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
