

## **BILL NO. 21-28**

AN ORDINANCE APPROVING THE AWARD OF BID NO. 2021-034, TO PURCHASE BULK ROCK ON AN AS-NEEDED BASIS FOR A ONE-YEAR TERM WITH UP TO FOUR, ONE-YEAR RENEWALS TO MARTIN MARIETTA KANSAS CITY, LLC AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME FOR THE CITY.

WHEREAS, the City of Lee's Summit, Missouri (the "City"), through the Procurement and Contract Services Division, issued Bid No. 2021-034 ("Bid") for Bulk Rock; and,

WHEREAS, the Bid was advertised through the City's e-procurement system, Public Purchase, and sent to 35 potential bidders; and,

WHEREAS, at the close of the Bid two (2) bidders had submitted responsive and responsible bids; and,

WHEREAS, Section 4 of the Procurement Policy requires City Council approval if an existing City contract has or is anticipated to have an annual spend of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The City Council hereby approves the City's the award of Bid No. 2021-034 to Martin Marietta Kansas City, LLC.

SECTION 2. The City Council approves an agreement between the City and Martin Marietta Kansas City, LLC, attached as Exhibit A and incorporated herein by reference, to purchase bulk rock, and authorizes the City Manager to execute the same in substantially the same form as the attached on behalf of the City.

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences, or clauses.
