AN ORDINANCE APPROVING THE AWARD OF BID NO. 40432472 FOR THE FY2017 CURB REPAIR PROGRAM TO PHOENIX CONCRETE & UNDERGROUND, L.L.C., AND AUTHORIZING THE CITY MANAGER TO ENTER INTO TO AN AGREEMENT FOR THE SAME IN THE AMOUNT OF \$1,080,964.55.

WHEREAS, the annual Curb Program replaces damaged and deteriorated curb on streets scheduled for an overlay during the following fiscal year; and,

WHEREAS, the annual Curb Program also updates sidewalk approaches to current specifications required by the Federal Americans with Disabilities Act (A.D.A.); and,

WHEREAS, the City received two (2) bids for this project; and,

WHEREAS, Phoenix Concrete & Underground, L.L.C. was found to be the lowest and most responsible bidder.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit, Missouri hereby authorizes the award of bid no. 40432472 for the FY2017 Curb Repair Program to Phoenix Concrete & Underground, L.L.C. in the amount of \$1,080,964.55.

SECTION 2. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the City Manager, of an agreement with Phoenix Concrete & Underground, L.L.C. for the services contained in bid no. 40432472, generally for the FY2017 Curb Repair Program, in an amount of \$1,080,964.55, said agreement is on file with the Lee's Summit Public Works Department and is incorporated by reference as if fully set forth herein.

SECTION 3. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
