

## **BILL NO. 20-19**

AN ORDINANCE APPROVING AMENDMENT NO. 5 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020, AS ADOPTED BY ORDINANCE NO. 8643 AND ORDINANCE NO. 8652, BY REVISING THE AUTHORIZED AMOUNT OF FULL TIME EQUIVALENTS FOR CERTAIN POSITIONS WITHIN THE CITY OF LEE'S SUMMIT WATER UTILITIES DEPARTMENT AND ESTABLISHING A NEW PAY AND CLASSIFICATION PLAN.

WHEREAS, Ordinance No. 8643 and Ordinance No. 8652, passed by the City Council on June 11, 2019, adopted the authorized amount of Full Time Equivalents for positions in the City of Lee's Summit and established a pay and classification plan; and,

WHEREAS, Ordinance No. 8660, passed by the City Council on July 9, 2019, and Ordinance No. 8721, passed by the City Council on September 17, 2019, amended the authorized amount of Full Time Equivalents for certain positions in the Water Utilities Department; and,

WHEREAS, approval of this amendment will create and authorize a new position within the Water Utilities Department titled Utility Billing Specialist; and,

WHEREAS, it is necessary for the Water Utilities Department to convert a Meter Technician position to a Utility Billing Specialist position; and,

WHEREAS, this action will not amend the total expenditures or the total number of Full Time Equivalents for the Water Utilities Department; and,

WHEREAS, it is necessary to make additional changes to certain positions in the pay and classification plan, including updates to comply with minimum wage and a position title change.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Fiscal Year 2019-2020 Water Utilities Department Full Time Equivalents for certain positions, as adopted by Ordinance No. 8721, is hereby amended as outlined in Exhibit A attached and incorporated herein by reference.

SECTION 2. The Fiscal Year 2019-2020 Pay and Classification Plan, as adopted by Ordinance No. 8660, is hereby repealed and replaced by the pay and classification plan, attached hereto as Exhibit B attached and incorporated herein by reference.

SECTION 3. All other provisions of Ordinances No. 8643 and No. 8652 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8653), Amendment No. 2 (Ordinance No. 8660), Amendment No. 3 (Ordinance No. 8707), and Amendment No. 4 (Ordinance No. 8721).

SECTION 4. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 5. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
