

**Memorandum of Understanding  
Regarding IMPACT Program**

This memorandum of Understanding (“MOU”) is entered into by and between Blue Springs R-IV School District (“District”) and the City of Lee’s Summit, Missouri (“City”) (collectively, “the Parties”).

WHEREAS, IMPACT is an anti-drug and stress management curriculum built around a current and ever-changing culture that teaches students to make smart and healthy decisions using the core values of integrity, responsibility, respect, and prevention;

WHEREAS, the City received a grant from the Jackson County COMBAT Drug Commission (“COMBAT grant”) to assist in defraying the cost of the City’s IMPACT (“IMPACT”) programs;

WHEREAS, the City provides law enforcement officers who provide IMPACT education in the District’s elementary schools (Chapel Lakes and Voy Spears Jr.) via City funding and the Jackson County COMBAT Drug Commission (“COMBAT grant”);

WHEREAS, the IMPACT program directly benefits District students by providing education to resist the use of tobacco, alcohol, marijuana, and vaping, as well as, providing an understanding of the skills to manage stress, resist peer pressure, and control emotions during conflicts;

WHEREAS, the Parties desire to define their relationship and duties regarding the implementation of the IMPACT program at Chapel Lakes and Voy Spears Jr. Elementary Schools.

NOW THEREFORE, in consideration of the mutual covenants contained herein, the Parties do hereby agree as follows:

1. **Effective Date.** This MOU shall become effective upon execution by the Parties.
2. **Term and Renewal.** The term of the MOU shall be from the Effective Date to June 30, 2024. Thereafter, it shall automatically continue and renew for one-year terms on June 30 of each year that COMBAT funds are provided by the County or so long as the City otherwise obtains funding for the IMPACT program.
3. **Services.** Based on available staffing, the City shall provide (2) IMPACT officers for the instruction at District elementary schools within the boundaries of the City of Lee’s Summit. The IMPACT officers shall be responsible for implementing the IMPACT program curriculum at Chapel Lakes and Voy Spears Jr. Elementary Schools, specifically providing IMPACT education to 5<sup>th</sup> grade students, as well as, introductory lessons to students in both 2<sup>nd</sup> and 4<sup>th</sup> grades. The City shall work collaboratively with the District to align the IMPACT curriculum with the District curriculum and programming to promote the maximum benefit for students.

4. **Qualifications.** The Parties agree that officers whom the City assigns to be IMPACT officers shall demonstrate the following qualifications:

- a. An interest in working with youth;
- b. Have training in IMPACT curriculum;
- c. Be employed and in good standing with the City's Police Department;
- d. Demonstrate appropriate temperament for working with students, school officials, and diverse groups;
- e. Ability to set a good example to students (on and off duty) and serve as a role model.

5. **Officer Removal.** The Parties recognize that the District has the ultimate authority regarding personnel who work within its buildings. The District may decline to accept an IMPACT officer assignment or may request the removal of a particular officer as an IMPACT officer, but the District shall not exercise this right unreasonably. In such circumstances, the following procedure shall apply.

- a. The District and the City shall first engage in a dialogue regarding the District's concerns about the officer in question and shall attempt to work collaboratively to resolve the concern. The District and City shall give a reasonable amount of time for any corrective actions outlined to be completed by the IMPACT officer.
- b. If the District and City are unable to resolve the District's concern informally, the District shall provide written notice of its request to remove the officer from the IMPACT assignment.
- c. The District shall give the City a reasonable timeframe to make any adjustment in assignments to avoid any disruption to the educational process or programs and to police staffing and resources.
- d. The City will provide a replacement IMPACT officer when and if staffing levels and City policies permit.

6. **Training.** The City shall be solely responsible for all training and professional development of the IMPACT officers regarding the IMPACT programs. The District shall be solely responsible for training IMPACT officers regarding District policies, procedures, and internal programs with which the District asks the officers to be familiar. The IMPACT officers shall attend District training to the extent such training is made available during their regular working hours.

7. **Equipment and Technology.** The District will provide each IMPACT officer with computer access to the District's computer network (but not to the confidential records stored thereon), and limited access to the District's student information management system

(PowerSchool, Schoology, IFS, etc.), to the extent permitted by the Family Educational Rights and Privacy Act, 20 U.S.C § 1232g, et seq. ("FERPA") and Missouri Law. The City will be responsible for providing all other equipment requirements to allow IMPACT officers to execute their duties.

8. **Data Collection.** IMPACT officers may collect de-identified demographic data of the participating students in each curriculum including but not limited to the number of students, gender, ethnicity, and zip code. This information will only be collected for official program use. Collection and release of the data will only occur as permitted by FERPA, Missouri Law, and Board Policies.

For the purpose of providing exceptional curriculum, IMPACT officers may conduct surveys of District staff for program and trainer feedback. This feedback will be used for the sole purpose of bettering the course material and teaching method. Additionally, staff may be asked for their opinions on growing trends or concerns within the schools, community, or society in general. This will assist in modifying the curriculum to meet the current or growing challenges and stressors students may be facing.

9. **Termination.** Either Party may terminate this MOU for any reason by providing thirty (30) days written notice to the other party.

10. **Continuation of Program.** IMPACT officer services that have heretofore been provided to the District by the City shall continue without interruption, and upon execution of this MOU shall be governed by the terms stated herein.

11. **Assignment.** The Parties may not assign their rights or obligations under this MOU without the prior written consent of the other party.

12. **Applicable Law.** The validity of this MOU and the rights, obligations, and relations of the parties hereunder shall be construed and determined under and in accordance with the laws of the State of Missouri; provided, however, that if any provision of the agreement is determined by a court of competent jurisdiction to be in violation of any applicable law or otherwise invalid or unenforceable, such provision shall to the extent as it shall be determined to be illegal, invalid or unenforceable under such law be deemed null and void, but this agreement shall otherwise remain in full force and effect.

13. **Insurance.** The parties agree and acknowledge that, as Missouri political subdivisions, each maintains appropriate insurance coverage in compliance with Missouri law.

14. **No Hold Harmless.** Each Party shall be responsible for the acts and omissions of its officers, agents, and employees. The City is not authorized or empowered to make any commitments or incur any obligation on behalf of the District, but merely provides services described herein as an independent contractor. Neither the City nor the District agrees to protect or hold harmless the other party from any claims of persons or companies for injuries to persons or property arising out of services herein identified.

15. **Amendments.** To provide the necessary flexibility for the most effective execution of this MOU, the parties may amend or modify this MOU by mutual written agreement.

16. **Entire Agreement.** This MOU supersedes any prior agreements or memorandums of understanding between the Parties regarding the subject matter of this MOU. The Parties agree this document embodies the entire terms and conditions of the MOU described herein, and that all words, phrases, sentences, and paragraphs, including recitals hereto, are material to the execution hereof.

17. **Severability.** It is mutually agreed that in case any provision of this MOU is determined by a court of law to be unconstitutional, illegal, or unenforceable, it is the intention of the parties that all other provisions of the MOU shall remain in full force and effect.

18. **Execution in Counterparts.** The Parties agree that this MOU may be signed in identical counterparts and/or facsimile and that all executed copies, whether signed in counterparts, facsimile, or otherwise, are duplicate originals, and are equally admissible in evidence.
