

## **BILL NO. 22-144**

AN ORDINANCE AUTHORIZING THE CITY TO SPEND ADDITIONAL FUNDS TO PURCHASE ADDITIONAL SOFTWARE LICENSES AND SERVICES PURSUANT TO THE SOFTWARE LICENSE AND SERVICES AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT AND CENTRALSQUARE TECHNOLOGIES, LLC, AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL DOCUMENTS NECESSARY TO EFFECTUATE THE SAME ON BEHALF OF THE CITY.

WHEREAS, pursuant to Ordinance No. 8456, the City executed a Software License and Services Agreement ("Agreement") with Zuercher Technologies, LLC ("Zuercher") to acquire and implement, among other things, a computer aided dispatch and records management system ("CAD/RMS System"); and,

WHEREAS, after the approval of Ordinance No. 8456, Zuercher merged with CentralSquare Technologies, LLC ("CST"), and CST assumed Zuercher's obligations under the Agreement; and,

WHEREAS, the CAD/RMS System was initially implemented and configured to serve only the Lee's Summit Police Department ("LSPD"); and,

WHEREAS, the Lee's Summit Fire Department ("LSFD") needs an updated dispatch system and the City would like CST to modify the LSPD's CAD/RMS System so it can also serve the needs of the LSFD; and,

WHEREAS, the additional products and services will cause the contract to price to increase by more than \$50,000.00 over the originally approved price; and,

WHEREAS, Section 8.1.2 of the City's Procurement Policy requires City Council approval when modifications to a contract result in an increase of \$50,000.00 or more.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, AS FOLLOWS:

SECTION 1. The City Council hereby approves and authorizes the purchase of additional software products and associated services as set forth in the sales order, attached as Exhibit A and incorporated herein, issued pursuant to the Software License and Services Agreement between the City of Lee's Summit, Missouri and CentralSquare Technologies, LLC.; authorizes the City to increase the aggregate contract price from \$504,000.00 to \$780,000.00; and authorizes the City Manager to execute all documents necessary to effectuate the same by and on behalf of the City of Lee's Summit.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
