

**ADDENDUM #2 TO SERVICE AGREEMENT FOR MEDIA MANAGEMENT SOFTWARE
PSA NO. 2012-107/2R**

THIS ADDENDUM #2 to Service Agreement for Media Management Software, PSA No. 2012-107/2R is made and entered into this _____ day of June, 2017, by and between the City of Lee's Summit, Missouri, a Municipal Corporation of the State of Missouri, hereinafter referred to as "City," and Granicus, Inc., a corporation in the State of California, hereinafter referred to as "Service Provider."

WITNESSETH:

WHEREAS, City and Service Provider originally entered into an agreement for Media Management Software on or about September 18, 2007 (hereinafter the "Original Agreement"); and,

WHEREAS, City and Service Provider modified the Original Agreement by executing the Service Agreement for Media Management Software, PSA No. 2012-107/2R on November 11, 2014, which is attached hereto as "Exhibit 1" and incorporated herein as if fully set forth; and,

WHEREAS, City and Service Provider incorporated an additional scope of services by entering into Addendum #1 to Service Agreement for Media Management Software, PSA No. 2012-107/2R on or about December 23, 2015, which is attached hereto as "Exhibit 2" and incorporated herein as if fully set forth; and,

WHEREAS, City and Service Provider desire to further modify the Service Agreement for Media Management Software, PSA No. 2012-107/2R, subject to Addendum #1, by further amending the scope of services to include the provision of VoteCast with iLegislate and Meeting Efficiency products to the City's current platform, and amending the amount not to exceed to account for costs associated with the implementation and ongoing maintenance of said products, without modifying any other terms or conditions of the Service Agreement for Media Management Software, PSA No. 2012-107/2R, subject to Addendum #1.

NOW, THEREFORE, in consideration of the mutual covenants and considerations herein contained, it is hereby agreed by the parties hereto as follows:

1. Paragraph #2 – Services of the Service Agreement for Media Management Software, PSA No. 2012-107/2R shall hereby be further modified to include the VoteCast and Meeting Efficiency Upgrade Scope of Work, attached hereto as "Exhibit 3." All remaining provisions of Paragraph #2 – Services of the Service Agreement for Media Management Software, PSA No. 2012-107/2R, subject to Addendum #1, shall remain in full force and effect.
2. Paragraph #3 – Amount Not to Exceed of the Service Agreement for Media Management Software, PSA No. 2012-107/2R as amended by Addendum #1 shall be deleted in its' entirety and replaced with the following:

Upfront, one-time costs associated with the purchase of hardware as well as the provision of training and professional services for implementation of Vote Cast and Meeting Efficiency Upgrades shall not exceed FIVE THOUSAND FOUR HUNDRED FIFTY NINE AND NO/100 DOLLARS (\$5,459.00).

Once the system has been implemented and upgraded, it is expressly understood that the total compensation to be paid to Service Provider for ongoing Monthly Managed Service costs for all products under this and previous Agreements and Addenda shall increase from the current rate of TWO THOUSAND EIGHT HUNDRED FIVE AND NO/100 DOLLARS (\$2,805.00) per month to an amount not exceed FOUR THOUSAND FOUR HUNDRED TWENTY AND NO/100 DOLLARS (\$4,420.00) per month, as more fully described in the attached "Exhibit 3."

3. All remaining provisions of the Service Agreement for Media Management Software, PSA No. 2012-107/2R, as modified by Addendum #1, as well as Exhibits, shall remain in full force and effect.

4. This Agreement shall be binding on the parties thereto only after it has been duly executed and approved by the City and the Service Provider.
