AN ORDINANCE AUTHORIZING THE EXECUTION OF A STATE BLOCK AGREEMENT BY AND BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI, AND THE MISSOURI HIGHWAYS AND TRANSPORTATION COMMISSION, GRANTING STATE FUNDS IN THE AMOUNT OF \$9,372,772.00 FOR RUNWAY 18-36 IMPROVEMENTS AT THE LEE'S SUMMIT MUNICIPAL AIRPORT.

WHEREAS, the runway 18-36 improvements at the Lee's Summit Municipal Airport (the "Project") includes construction to rehabilitate and strengthen Runway 18/36, extend Runway 18/36, extend Runway 11/29; and Runway 18/36 and 11/29 lighting improvements, relocation of water mains, extend wildlife fencing; and,

WHEREAS, this State Block Grant is in the amount of \$9,372,772.00 (funding 90% of the cost of the construction and inspection for the Project) and is to be used for the costs of the Project; and

WHEREAS, local matching funds of \$520,709.00 (5% of the Project cost) are required and are available from the Airport Construction Fund.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the City Council of the City of Lee's Summit hereby authorizes the execution, by the Mayor on behalf of the City of Lee's Summit, of a state block grant agreement by and between the Missouri Highways and Transportation Commission and the City of Lee's Summit, Missouri for runway 18-36 improvements at the Lee's Summit Municipal Airport, which is attached hereto and incorporated by reference as if fully set forth herein.

SECTION 2. That this Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.
