AN ORDINANCE APPROVING THE EXTENDED SUPPORT AGREEMENT FOR THE LAWSON ENTERPRISE RESOURCE PLANNING SYSTEM BY AND BETWEEN INFOR (US) INC. (FORMERLY LAWSON SOFTWARE AMERICAS, INC.) AND THE CITY OF LEE'S SUMMIT, MISSOURI IN THE AMOUNT OF \$28,755.11 AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME BY AND ON BEHALF OF THE CITY.

WHEREAS, in 2011, the City of Lee's Summit, Missouri (hereinafter "City") acquired the Lawson Enterprise Resource Planning System (hereinafter "Lawson") as a comprehensive software system to manage the City's Finance, Procurement, Human Resources, Payroll and Budgeting functions; and,

WHEREAS, it is necessary for the City to continue to receive services from the software vendor in the form of associated maintenance, including, among other things, the implementation of additional features, improvements, product fixes and other related software support services; and,

WHEREAS, due to the age of the product purchased by the City, it is necessary for the City to upgrade to a more current release of the product, which is budgeted and scheduled for FY2017; and,

WHEREAS, until said upgrade is completed, additional software support of the current product is still needed but will only be provided by the software vendor at a premium price, requiring the execution of an Extended Support Agreement, which outlines the services to be provided as well as the cost for acquiring such services; and,

WHEREAS, City desires to engage Infor (US) Inc. (formerly Lawson Software Americas, Inc.) to provide extended support to Lawson until the upgrade can be completed.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. That the Extended Support Agreement for the Lawson Enterprise Resource Planning System by and between Infor (US) Inc. (formerly Lawson Software Americas, Inc. and the City of Lee's Summit, Missouri in the amount of \$28,755.11, a copy of which is attached hereto as Exhibit A be and hereby is approved ,and the City Manager is authorized to execute the same by and on behalf of the City.

SECTION 2. That this ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. That should any section, sentence, or clause of this ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
