AN ORDINANCE APPROVING AMENDMENT NO. 12 TO THE BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2020, AS ADOPTED BY ORDINANCE NO. 8643 AND ORDINANCE NO. 8652, BY AMENDING THE AUTHORIZED EXPENDITURES OF THE CITY OF LEE'S SUMMIT, MISSOURI.

WHEREAS, Ordinance No. 8643 and Ordinance No. 8652, passed by the City Council on June 11, 2019, adopted the authorized expenditures for the City's Budget for the Fiscal Year ending June 30, 2020; and,

WHEREAS, to close out each fiscal year it is necessary to review the end of the year expenditures and authorize an amendment for Funds and General Fund Departments that had actual expenditures greater than authorized budget expenditures; and,

WHEREAS, pursuant to Section 11.7 of the City Charter, the City Manager has certified that there are available for appropriations funds in excess of those estimated in the Budget.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The Budget for the Fiscal Year ending June 30, 2020, as adopted by Ordinance No. 8643 and No. 8652, is amended in the manner shown in Exhibit A, attached and incorporated herein by reference.

SECTION 2. All other provisions of Ordinances No. 8643 and No. 8652 shall remain in full force and effect, subject to Amendment No. 1 (Ordinance No. 8653), Amendment No. 2 (Ordinance No. 8660), Amendment No. 3 (Ordinance No. 8707), Amendment No. 4 (Ordinance No. 8721), Amendment No. 5 (Ordinance No. 8808), Amendment No. 6 (Ordinance No. 8828), Amendment No. 7 (Ordinance No. 8829), Amendment No. 8 (Ordinance No. 8830), Amendment No. 9 (Ordinance No. 8851), Amendment No. 10 (Ordinance No. 8859), and Amendment No. 11 (Ordinance No. 8886).

SECTION 3. This Ordinance shall be in full force and effect from and after the date of its adoption, passage, and approval by the Mayor.

SECTION 4. Should any section, sentence, or clause of this Ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
