

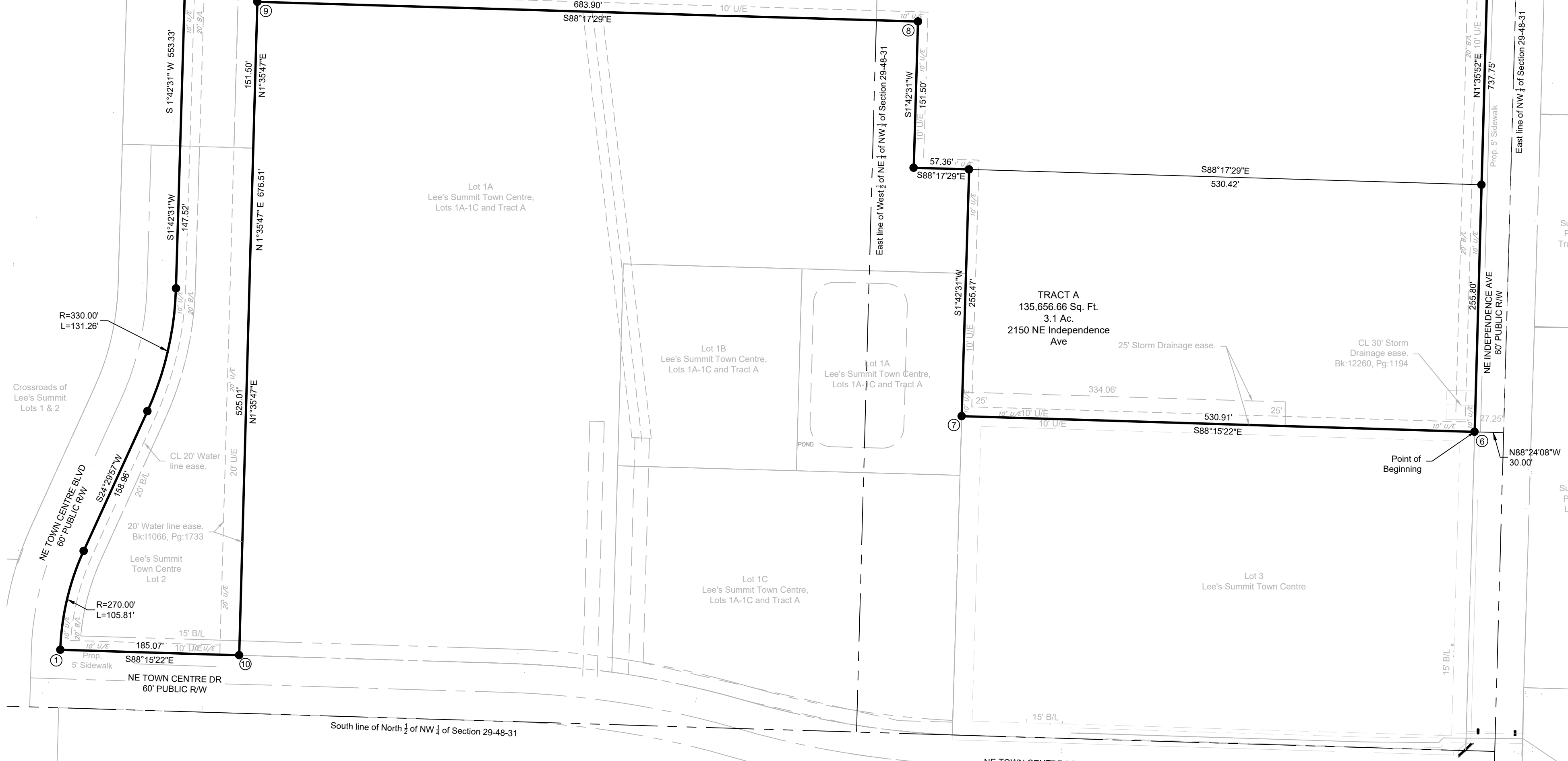

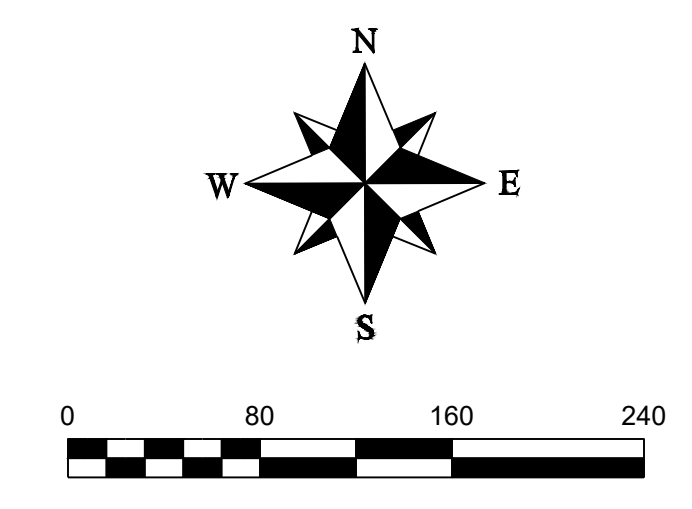

Replat of Lot 2, Lee's Summit Town Centre, Lot 1 & Lot 2

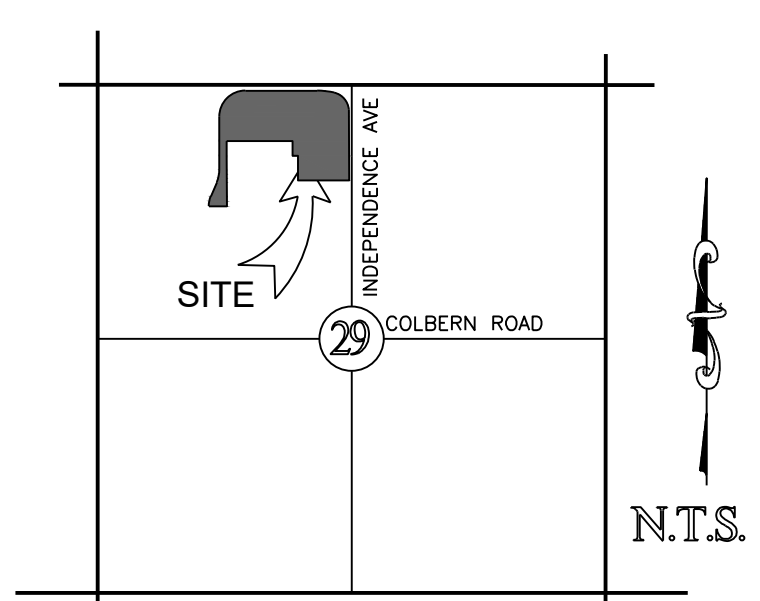

PLAT DESCRIPTION:

A TRACT OF LAND SITUATED IN SECTION 29, TOWNSHIP 48 NORTH, RANGE 31 WEST, IN LEE'S SUMMIT, JACKSON COUNTY, MISSOURI, MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE NORTHEAST CORNER OF THE NORTHWEST QUARTER OF SAID SECTION 29; THENCE S 1°35'52" W, A DISTANCE OF 991.64 FEET; THENCE N 88°24'08" W, A DISTANCE OF 30.00 FEET TO THE POINT OF BEGINNING; THENCE N 1°35'52" E, A DISTANCE OF 737.75 FEET; THENCE ALONG A CURVE TO THE LEFT HAVING AN INITIAL TANGENT BEARING OF N 4°05'24" W AND A RADIUS OF 198.61 FEET, AN ARC DISTANCE OF 246.30 FEET; THENCE ALONG A CURVE TO THE LEFT HAVING AN INITIAL TANGENT BEARING OF N 70°25'07" W AND A RADIUS OF 948.11 FEET, AN ARC DISTANCE OF 17.85 FEET; THENCE N 88°15'22" W, A DISTANCE OF 746.94 FEET; THENCE ALONG A CURVE TO THE LEFT TANGENT TO THE PRECEDING COURSE AND HAVING A RADIUS OF 270.00 FEET, AN ARC DISTANCE OF 424.28 FEET; THENCE S 1°42'31" W, A DISTANCE OF 553.33 FEET; THENCE ALONG A CURVE TO THE RIGHT TANGENT TO THE PREVIOUS COURSE AND HAVING A RADIUS OF 330.00 FEET, AN ARC DISTANCE OF 131.28 FEET; THENCE S 24°25'07" W, A DISTANCE OF 158.96 FEET; THENCE ALONG A CURVE TO THE LEFT TANGENT TO THE PREVIOUS COURSE AND HAVING A RADIUS OF 270.00 FEET, AN ARC DISTANCE OF 105.81 FEET; THENCE S 88°15'22" E, A DISTANCE OF 185.07 FEET; THENCE S 88°17'29" E, A DISTANCE OF 57.36 FEET; THENCE S 1°42'31" W, A DISTANCE OF 255.47 FEET; THENCE S 88°15'22" E, A DISTANCE OF 530.91 FEET TO THE POINT OF BEGINNING.

CONTAINING 974,070.64 SQUARE FEET (22.36 ACRES) MORE OR LESS.

DEDICATION:

EASEMENTS:

AN EASEMENT OR LICENSE IS HEREBY GRANTED TO THE CITY OF LEE'S SUMMIT, MISSOURI, TO LOCATE, CONSTRUCT AND MAINTAIN, OR TO AUTHORIZE THE LOCATION, CONSTRUCTION AND MAINTENANCE OF POLES, WIRES, ANCHORS, CONDUITS, AND/OR STRUCTURES FOR WATER, GAS, SANITARY SEWER, STORM SEWER, SURFACE DRAINAGE CHANNEL, ELECTRICITY, TELEPHONE, CABLE TV, OR ANY OTHER NECESSARY PUBLIC UTILITY OR SERVICES, ANY OR ALL OF THEM, UPON, OVER, OR UNDER THOSE AREAS OUTLINED AND DESIGNATED UPON THIS PLAT AS "UTILITY EASEMENTS" (U.E.), "DRAINAGE EASEMENT" (D.E.) OR WITHIN ANY STREET OR THOROUGHFARE DEDICATED TO THE PUBLIC USE ON THIS PLAT, GRANTOR, ON BEHALF OF HIMSELF, HIS HEIRS, HIS ASSIGNS AND SUCCESSORS IN INTEREST, HEREBY WAIVES, TO THE FULLEST EXTENT ALLOWED BY LAW, INCLUDING, WITHOUT LIMITATIONS, SECTION 527.188, RSMo (2006), ANY RIGHT TO REQUEST RESTORATION OF RIGHTS PREVIOUSLY TRANSFERRED AND VACATION OF THE EASEMENTS HEREIN GRANTED.

STREETS:

THE STREETS AND/OR THOROUGHFARES SHOWN ON THIS PLAT AND NOT HERETOFORE DEDICATED TO PUBLIC USE ARE HEREBY SO DEDICATED.

BUILDING LINES:

BUILDING LINES OR SETBACK LINES ARE HEREBY ESTABLISHED AS SHOWN ON THE ACCOMPANYING PLAT AND NO BUILDING OR PORTION THEREOF SHALL BE CONSTRUCTED BETWEEN THIS LINE AND THE STREET RIGHT OF WAY LINE.

OIL - GAS WELLS:

THERE IS NO VISIBLE EVIDENCE OF ABANDONED OIL OR GAS WELLS LOCATED WITHIN THE PLAT BOUNDARIES, AS IDENTIFIED IN "ENVIRONMENTAL IMPACT STUDY OF ABANDONED OIL AND GAS WELLS IN LEE'S SUMMIT, MISSOURI," EDWARD ALTON MAY JR., P.E., 1995.

FLOODPLAIN:

THIS PROPERTY IS NOT WITHIN THE BOUNDARIES OF THE 100 YEAR FLOOD ZONE ACCORDING TO FEMA FLOOD INSURANCE MAP, NUMBER 29095C0430G, DATED JANUARY 20, 2017.

STORM WATER:

ALL STORM WATER CONVEYANCE, RETENTION, OR DETENTION FACILITIES TO BE LOCATED ON COMMON PROPERTY SHALL BE OWNED AND MAINTAINED BY THE PROPERTY OWNERS' ASSOCIATION WITH THE STANDARDS SET FORTH IN THE COVENANTS, CONDITIONS, AND RESTRICTIONS. THESE STORM WATER DETENTION FACILITIES SHALL BE INSPECTED BY THE PROPERTY OWNERS' ASSOCIATION, OR OWNER AS APPROPRIATE ON THE FREQUENCY SPECIFIED IN THE CURRENT CITY OF LEE'S SUMMIT DESIGN AND CONSTRUCTION MANUAL, TO ASSURE THAT ALL INLET AND OUTLET STRUCTURES ARE FULLY FUNCTIONAL, THE DETENTION BASIN HAS FULL STORAGE CAPACITY AND ALL LANDSCAPING, VEGETATION AND STRUCTURAL IMPROVEMENTS ARE BEING MAINTAINED IN ACCORDANCE WITH THE CURRENT CITY OF LEE'S SUMMIT PROPERTY MAINTENANCE CODE.
