AN ORDINANCE APPROVING AN AGREEMENT BETWEEN THE CITY OF LEE'S SUMMIT, MISSOURI AND COLLISION FORENSIC SOLUTIONS, FOR THE PURCHASE OF THE LEICA GEOSYSTEMS RTC360 HDS 3D LASER SCANNER PACKAGE WITH ADDITIONAL OPTIONS AND AUTHORIZING THE CITY MANAGER TO EXECUTE THE SAME ON BEHALF OF THE CITY.

WHEREAS, the Lee's Summit Police Department has experienced an increase in complex investigations related to violent crimes and serious crashes, more advanced documentation of these scenes is imperative for public transparency; and,

WHEREAS, Collision Forensic Solutions is the only vendor to offer 24-hour, lifetime operational support for the equipment and software, and is the only IAI certified & ACTAR accredited Leica law enforcement distributor authorized in the state of Missouri;

WHEREAS, the City needs to equip its police officers with proper tools to ensure additional levels of accuracy and thoroughness in complex crime scene investigations; and;

WHEREAS, the City wishes to purchase the Leica Geosystems RTC360 HDS 3D Laser Scanner package with additional options from Collision Forensic Solutions pursuant to the attached agreement.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LEE'S SUMMIT, MISSOURI, as follows:

SECTION 1. The agreement by and between the City and Collision Forensic Solutions., attached as Exhibit A and incorporated by reference, for the purchase of Leica Geosystems RTC360 HDS 3D Laser Scanner package with related equipment, training and support for the Lee's Summit Police Department for an amount not to exceed \$114,844.49 is approved, and the City Manager is authorized to execute the same in substantially the same form as the attached and all other documents as may be necessary to carry out and comply with the intent of this Ordinance.

SECTION 2. This Ordinance shall be in full force and effect from and after the date of its passage and adoption, and approval by the Mayor.

SECTION 3. Should any section, sentence, or clause of this ordinance be declared invalid or unconstitutional, such declaration shall not affect the validity of the remaining sections, sentences or clauses.
