- Cost coverages by each taxing component

Ms. Kelly Bride spoke in opposition to this application due to the CID covering the costs or roadways and stormwater. She also does not feel the higher density mixed residential does not fit into this area. She would like to have higher standards considered for this area.

After Ms. Bride spoke - Council discussion included:

- State funding for roads is not sufficiently covered by the state
- These are funded by the developer and not under CID or TDD
- Stormwater coverage is being handled by developer also - to get it through the site
- Apartment developing is not part of the CID as one of the petitioners
- Stormwater
- Land use

10. Committee Reports

Councilmember Shields stated there would be a Finance and Budget Committee tomorrow night, September 6, 2023 at 4:00pm in Council Chambers and they will be discussing the Reserve Balance Policy.

Councilmember Edson stated the Community and Economic Development Committee will meet on Wednesday, September 13, 2023 and they will be discussing political signs / locations.

Councilmember DeMoro stated the Legislative and Intergovernmental Relations Committee will meet on Monday, September 11, 2023 at 11:30am and the Public Works Committee will also meet on that day at 4:30pm.

11. Council Comments:

Councilmember Prier asked questions regarding Colbern Road and the utilities being moved, who paid for that and what is the cost. She also asked if there was more cost efficient to move them or bury them. Mr. Michael Park, Director of Public Works, stated these depend on the construction and the ability to bury or move them. Councilmember Lovell stated the City should look at all options when moving / burying / replacing utilities as well as new development and long term objectives and goals.

Councilmember Prier also asked if staff could arrange to have someone from Evergy speak to the public regarding the upcoming changes to energy saving plans and why certain parts of Missouri can opt out but Lee's Summit can't. Mr. Dunning stated staff would look into arranging this.

Councilmember Edson asked of the Discovery Park project would be using a "Native Plant Plan".

12. Staff Roundtable

Mr. Mark Dunning, City Manager, stated that due to the number of appeals with Jackson County, the City will be getting the final assessed value back later than usual. The Public Hearing is scheduled for September 19 and the assessments may come as late as September 11 which will likely change the numbers drastically. The ordinance will be made an emergency ordinance in order to meet the legal deadline for the Tax Levy.

Mr. Dunning also recognized Ms. Kara Stalin for being recognized by the State of Missouri as Floodplain Manager of the Year.

Additionally, Mr. Dunning advised the Snow Rodeo is being held September 15th and there are spots for "celebrity drivers" if the Council is interested in participating. It will be held at the Public Works Maintenance Facility and there will be a luncheon that day as well.
