A. <u>2016-0449</u> Presentation on Show Me Heroes Program

Mr. Wayne Woodworth explained the purpose for the Show Me Heroes

Program, which is designed to develop a partnership between veterans and the City, including incentives for hiring a veteran and providing on-the-job training. Over 4900 employers across the state participate in the program. Mr. Arbo advised that the program had already been implemented in the City and pointed out that paramilitary positions in municipalities provide a great transition for former and current military personnel. Discussion of Performance and Financial Audits (NOTE: This item was continued from August 11, 2016 per Council's request.)

Motion was made be Councilmember Forte, seconded by Councilmember Carlyle, to use Rubin Brown for an operation and forensic audit for the procurement process of the City.

The Council discussed this issue at some length. Councilmember Mosby distributed a two-page proposal entitled "2016 City Council Procurement Audit".

Councilmember Mosby moved for an AMENDMENT to the original motion to include the items listed on his sheet, with a change to the wording under "Minimum Auditor Criteria" to read: The auditors, i.e., individual auditors at Rubin Brown, shall not have previously worked with or for the city of LS. Motion was seconded by Councilmember Moreno. AMENDMENT PASSED on a vote of 5 "aye", 3 "no" (Councilmembers binney, Forte and Carlyle.

On the original motion made by Councilmember Forte, seconded by Councilmember Carlyle, with the approved amendment, the Council voted 5 "aye", 3 "no", to use Rubin Brown for an operational and forensic audit for the procurement process of the City, to include the provisions listed on the sheet submitted by Councilmember Mosby, entitled "2016 City Council Procurement Audit", as amended. (Councilmember Mosby's amendment is attached to the packet form for this item.)

8. <u>COMMITTEE REPORTS (Committee chairs report on matters held in Committee):</u>

Councilmember Mosby asked councilmembers to provide him with their visions for stormwater goals, to be discussed in the Public Works Committee meeting and then to City Council.

Councilmember Carlyle advised the next Budget Committee meeting will be on August 29th, due to the Labor Day holiday on September 5th.

Councilmember Seif noted the Rules Committee will meet on Monday at 5:00 p.m.

9. COUNCIL ROUNDTABLE:

- Councilmember Binney noticed this afternoon that the recycling bins at the schools were being removed due to increased costs form Deffenbaugh. He asked Staff to talk with Kansas City about the North Recycling Center on Lee's Summit Road. He suggested talking with HES to see if they would make recycling available. If not, how could be done with the North Recycling Center. Also, this might be the time to revisit a trash hauler contract, due to the many complaints about current service. He wondered if there was a public desire to select a hauler for the entire city, which may be the answer to the recycling problem, and he would be interested in public feedback.
- Councilmember Binney reminded the Council that e-mails were not the
 place to conduct business, only from the dais. If they wanted to take
 action or distribute information, that information should be brought to
 the meeting.
- Councilmember Moreno complimented the Police Department on a video running on the City's cable channel.
- Mayor Rhoads announced that the Fire Department obtained accreditation. This was a long process but worth the challenge. At the ceremony, there were amazing things said about the department and he felt the city should be extremely proud.
